Both full-time and part-time enrollments are paid at full-day rate.

The monthly reimbursement amount equals to 23 units of full-day rate shown above.

The reimbursement for the first month is determined based on the enrollment start date:

- If the enrollment start date is on the 15th day of the month or before, the reimbursement equals to 23 units.
- If the enrollment start date is after the 15th day of the month, the reimbursement equals to 11 units.
