COMMUNITY ACTION SERVICES



Services vary by agency but include Energy Assistance, Short-Term Crisis Services, and multiple other programs.

ENERGY ASSISTANCE

Energy Assistance may be available to eligible customers at or below 150% of the federal poverty limit. Assistance may take one of several forms:



Help to pay current and past due energy bills



Help with utility deposits



Help with energy efficiency measures to reduce future energy costs

SHORT-TERM CRISIS SERVICES

Short-Term Crisis Services offer emergency support in crisis situations such as loss of income, family separation due to domestic violence, and other unforeseen events that make it difficult to meet one's expenses. Income eligibility is at or below 150% of the federal poverty limit. Assistance may take multiple forms, including:



Rent or mortgage payments to prevent homelessness



Emergency shelter



Provision for needs related to maintaining or securing employment

OTHER

Other services vary by agency but may include:



Case management



Transportation



Financial literacy



Micro-lending and business incubators



GED preparation



Work search assistance



Nutrition assistance
