

Change Reporting Education



What do you need to report?

See the opposite side for a summary of what you need to report

- Supplemental Nutrition Assistance Program (SNAP)
- Transitional Benefit Assistance (TBA)
- Arizona Simplified Nutritional Assistance (AZ SNAP)
- \$ Cash Assistance, sometimes known as Temporary Assistance for Needy Families (TANF) (other then TPEP)
- \$ Two Parent Employment Program Cash (TPEP)



What happens if you don't report?

Failure to report changes or providing false information can result in disqualification, loss of benefits, fines and Criminal prosecution.



When do you need to report by?

If a change occurs we need to be notified no later then the 10th calendar day of the month following the change. (If the 10th falls on a weekend you have until the first workday after the 10th.)



How can you report a change?

You can report a change in person at one of our offices, on the phone by calling (855) 432-7587 or (855) 777-8590 or online at My Family Benefits (MFB). You can also report by fax or mail.



Reminder

Not all government programs are connected to each other. Information reported to another program may not be shared with FAA. Failure to report changes for your case directly to FAA may result in changes being unreported for these programs.

For a household size of, your reporting requirements are:	
SNAP	income exceeds 130% FPL \$ Able Bodied adults without dependents (ABAWD) report when work hours go below 20 per week or 80 per month. Lottery Winnings exceeding \$4,250
ТВА	A participant from the case moves out You wish to stop benefits from TBA
AZ SNAP	Lottery Winnings exceeding \$4,250 reporting changes in address and shelter costs can be beneficial
For CASH (except TPEP)	income exceeds A1 standard \$ dependant child moves out or is removed.
TPEP	Changes of income including employment, child support received, gifts from others etc. Changes in participant (including removal) Changes in primary case holder Change of address or shelter costs expenses for care of a child or disabled adult Child support expenses Changes in resources Changes in school attendance for anyone over 6 Changes in parental care of the children, (parent moving in/out, passing away, changing disability status or verifying the fathers identity)
