DDD Actions Related to COVID-19

DDD has implemented many **temporary measures** to support members and vendors as a result of COVID-19. These measures include new information about available services that can be delivered during school time based on assessed need. DDD is working with AHCCCS. We will let members and families know when a timeline is created for ending those temporary measures. This will help ensure a smooth transition for members and vendors.

Remember, according to the Arizona Department of Health Services you can help slow the spread of COVID-19 by doing these 6 things:

- Maintain physical distancing of at least 6 feet
- Avoid large groups and going out if possible
- Wear a face cover when you are out in public
- Cover your cough or sneeze
- Wash your hands for at least 20 seconds often
- Stay home when you are sick



Complete the 2020 Census




Data collection for the 2020 Census will end on September 30, 2020. It is important for members and families to complete the 2020 census. Completing the census is critical. An inaccurate census can result in lost federal dollars for programs and services including transportation, infrastructure, education and affordable housing. Governor Ducey Urges Arizonans to Get Flu Shot

Governor Ducey on August 31, 2020, announced a partnership with health care providers and businesses to prepare for the upcoming flu season. Arizona is taking enhanced steps to expand access to the flu vaccine. All Arizonans are encouraged to get it. Getting a flu shot is more important than ever during the COVID-19 pandemic. Arizona has established a new website to help Arizonans find a location near them to get a flu shot. Make an appointment with your PCP to get your flu shot. You can also find a location near you using the Vaccine Finder.



Family Caregiver Grant Program

Funding is available through a reimbursement program for family caregivers who provide care for their loved ones in their own homes. Family caregivers can be reimbursed 50% (up to \$1,000 for each qualifying family member) for qualified home modifications and other equipment used to help their loved ones live more independently.

The Family Caregiver Grant Program was established as a result of legislation. The program is for individuals who have qualifying expenses during a calendar year. These expenses must be related to the care and support a qualifying family member in their home. Applicants can call the Caregiver Resource Line at (888) 737-7494 to apply. Electronic Visit Verification (EVV) ensures, tracks and monitors timely service delivery and access to care for members. EVV is being implemented as a result of the 21st Century Cures Act. It is also a federal requirement.

The EVV systems electronically verify the:

- Type of service performed
- Individual receiving the service
- · Date of the service
- Location of service delivery
- Individual providing the service
- Time the service begins and ends

The DDD services impacted are:

- Attendant Care
- Homemaker/Housekeeping
- Habilitation Hourly
- Home Health (Nursing)

- Respite
- · Skills Training and Development

EVV applies to all providers of these services, **including** paid family direct care workers. Providers providing impacted services must begin using EVV on January 1, 2021. AHCCCS will be hosting events for members and families regarding EVV. Check **azahcccs.gov/evv** often for dates and times.

Arizona Partners in Leadership



The AZ Partners in Leadership program provides training, resources and skill building to self-advocates and parents of children with disabilities. Participants will meet and unite with others who have similar concerns. Participants learn how the legislative process works at the local, state and national levels. The goal of the training is to develop partnerships. These partnerships are between people who need services and those who make policy and law.

Participants will attend 8, 2-day sessions. The sessions will be held in Phoenix, but they may be held via video conference due to COVID-19.
