Introduction

This document presents the assumptions and methodology used by DES/DDD in compiling the benchmark rate schedule. The document is generally divided into the following sections:

This document presents a discussion of the assumptions used in the independent models. The rate presented in this document are generally for agency (RFQVA) providers only. Independent Provider rate have been developed for several services based on the agency provider rate. These Independent Provider rates are generally lower than the agency rates because of a reduction for employee-related expenses and administrative overhead, as well as a general cap at the agency rate. Independent Provider rates are adjusted for specific consumer characteristics through the Independent Provider Rate Assessment Tool.

Also, it should be noted that the rates presented in this document (Benchmark Rates) may be different from the actual reimbursement rates (Adopted Rates) that appear in the published rate schedule. Historically, due to budget constraints on the Division, the actual reimbursement rates (Adopted Rates) were set at a level lower than the Benchmark Rates. There may be instances where the Adopted Rates are higher (and lower) than the Benchmark Rates.

The first set of Benchmark Rates for most services was developed through an independent model rate setting process for SFY 2004. In accordance with the legislative mandate, the Division conducted a rate setting study completed in SFY 2014. The Benchmark Rates reflected in this document are the resultant rates obtained through the study completed in SFY 2104¹.

Data Sources

The following general sources were used in constructing the SFY 2015 rate models:

- ❑ Wage data from the Bureau of Labor Statistics (BLS) was used to determine the hourly wages for specific occupational categories. Wages used in the original models reflect their publication date of May 2012 and were subsequently adjusted for inflation.
- ❑ The Internal Revenue Service data was used for the mileage reimbursement rate.
- ❑ Inflation data from the *Health Care Cost Review*, published by Global Insight, CMS Home Health Agency Market Basket was used to inflate wage costs.
- ❑ Rent expense is based on data from the U.S. Department of Housing and Urban Development (HUD) for Fair Market Rents (FMR) for federal fiscal year 2013.
- ❑ Food expense is based on USDA Moderate-Cost Plan variations as of May 2012, inflated to December 2014.

General Assumptions

Wages

Generally, wages constitute the largest single component of the independent model and the Division placed a special emphasis on assuring that the wage levels used in the cost model were appropriate in light of their importance on the quality of services. The direct care wage rates selected for the independent models were derived from the Bureau of

Labor Statistics (BLS) data for Arizona job classifications. The BLS data was selected because of its wide availability and acceptance as a standard.

The mid-point between the 25th and 50th percentile data points for Arizona wage data from BLS, as published in May of 2012, was used to determine the hourly wages for specific occupational categories. Depending on the requirements of the direct staff job activities delineated in the service descriptions, certain services reflect a blended rate of wage data of more than one occupational code.

Wages were adjusted for inflation with the CMS Home Health Agency Market Basket inflation data from the *Health Care Cost Review*, published by Global Insight. The inflation factor for all wage categories is 6.33%. This reflects inflation from the May 2012 wage period of 1.10% for 2012 (June through December), 2.4% for 2013 and 2.7% for 2014.

Employment Related Expenditures (ERE)

Following wages, employment related expenses (ERE) generally constitute the second largest single component of the independent models and are the second most important factor impacting quality of direct care service and a stable workforce.

The independent models utilize one of three percentages based upon the direct care staff wages within the independent model. An ERE rate of 35% on wages less than \$13.00, 30% for wages between \$13.01 and \$19.99, and for models that use hourly wages of \$20.00 or more, 23.0%. These ERE percentages were derived from the following information:

Productivity of Direct Service Staff

Productivity factors are reductions to the amount of time during a scheduled work day that direct service staff cannot bill for service delivery. Obvious examples of reduced productivity would be the time it takes for a direct service staff person to travel to a member's home to deliver services or the time that the staff person spends in training. Productivity factors included in rate models emphasize time spent that improves the quality of service. i.e., staff training and medical records maintenance.

In most instances, the independent models assume that staff are paid for an eight hour day, the wage (and ERE) rates that the staff person is paid must be "grossed up" in the rate models to account for non-productive (or non-billable) time spent during the day. A simple example will illustrate the concept:

If a direct service staff person were being paid \$10 per hour, yet half of the staff member's eight hour day was spent on activities that were non-productive (or non-billable), the grossed up wage rate per billable hour would be \$20.

In the above situation, 8 hours multiplied by \$10 equals \$80 – the amount the staff person is being paid. However, with 4 hours of billable time, 4 hours multiplied by \$20 equals \$80 – the amount the provider must bill in a day in order to recover the full cost of the staff person's wages.

Some factors are standardized across all independent models, and some productivity factors were set uniquely for individual services. The more general productivity factors applied to the models include:

- **Recordkeeping and Documentation:** This productivity factor is generally included in the independent models to provide for adequate time for recordkeeping as this is considered non-billable time. There are three exceptions to this general rule: Homemaker; Habilitation, Individually Designed Living Arrangement, Daily; and Residential services.
- **Employer Time:** In general, all independent models now include a factor for employer time which is to account for weekly team meetings to support service delivery.
- **Training Time:** A standard productivity factor of 40 hours of annual training time was included for all non-professional independent models and 56 hours of annual training time was allotted for all professional services. Exceptions to this is the Day Treatment and Training, Child Summer and After-school program for which 78 hours of training time annually is allotted. These hours represent average training hours annually over a three year period.
- **Missed Appointments:** There was no standard productivity factor for missed appointments though adjustments were made for specific Home-Based services.

- **Travel Time:** There was no standard productivity factor for travel time though adjustments were made for specific home based services.
- **Participation in ISP Meeting or Member Assessments:** As appropriate, many of the independent rate models for services include a productivity adjustment to allow direct care staff to participate in ISP meetings and/or member assessments. The specific adjustment varies by service in recognition of the varying member case loads and other factors.

Program Support

The independent models include a specific component for program support costs. Program development and monitoring is a component of program support cost which have a direct impact on quality. Generally, this factor in the independent models is intended to represent costs defined as follows:

Program support costs are expenses that are neither direct care nor administrative. Such activities are program-specific, but not billable.

Administrative Expenses

The independent models include a specific component for administrative expenses. Generally, this factor in the independent modes is intended to represent costs defined as follows:

Administrative costs are those associated with the operation of your organization, but which are not program-specific. Employees that are typically considered administrative include general management, financial/accounting, and human resource staff.

Multiple Client Rate Calculation

For some services (most notably home-based services), it is possible for a provider to deliver services simultaneously to multiple members. The formula to determine the rate for each member receiving services is:

(Regular Rate * ((1 + (25% * number of additional members))) / Total number of members)

Travel Time Calculation

For some services where a staff member is required to travel between member sessions, travel time was included as a factor in productivity. The calculation of travel time was standardized between all of the rebased models. The following formula was used to determine the travel time.

(Number of miles traveled / 25 mph)+0.17

It is assumed the average speed is 25 miles per hour and an add-on of 10 minutes (10 minutes / 60 minutes = 0.17) is included to allow for loading and unloading into the vehicle.

Mileage Reimbursement Rate

The independent models include a standard mileage reimbursement rate of 56.5 cents per mile, except for Day Treatment, Group Home and Day Treatment Related Transportation services. These services use an ‘enhanced mileage rate’ that is discussed in the service specific methodologies. The standard mileage rate used in the rebase models is the published 2013 rate available from the Internal Revenue Service at <http://www.igrc.org/pages/detail/1884>.

Enhanced Mileage Rate

The independent models for Day Treatment and Training and Group Home (all variations) utilize a mileage factor of \$ 0.82 per mile. Essentially, the enhanced mileage rate is a rate per mile that is greater than the standard mileage rate of \$.565 per mile. Enhancements are made to the standard mileage rate to recognize the additional expenses associated with the acquisition of the higher cost vehicle for some programs.

The composition of the Enhanced Mileage Rate is:

Acquisition and Discount Assumptions

- Acquisition cost of the vehicle is \$37,500
- Lift installation costs are assumed at \$16,000
- The salvage value at the end of the 100,000 mile period is \$5,000. If the asset is disposed of prior to/after this mileage threshold, the salvage will be higher/lower than assumed.
- The net capital cost of the vehicle, including acquisition and lift installation is \$48,500.
- An absence/attendance factor of 85%.

Urban & Rural

A number of services have independent models that differentiate urban and rural. Unless specifically noted for a service the general definition for these terms in the application of the rate models is:

- Urban: Services provided within the geographic area encompassed by Maricopa and Pima counties are to be billed using “Urban” rates.
- Rural: Services provided outside of the geographic area encompassed by Maricopa and Pima counties are to be billed using “Rural” rates.

Three-Area Modified Rates

The independent models for Nursing, Therapy and Therapy Assistant Services utilize a three-area geographic modified rate depending on where the service is rendered. The Benchmark Rate itself represents the base geographic area defined by county. Two additional geographic areas defined as Area 1 and Area 2 will receive the Benchmark Rate increased by 10% for Area 1 and 25% for Area 2. The county designations for the three geographic areas differ for Nursing and Therapy/Therapy Assistant Services as shown below:

- Three sub-models reflect different staff-to-member ratios 1:3.5, 1:5.5, 1:7.5.
- Facilities are assumed to be in service for 250 days per year, although expenses are allocated over 212 days of member attendance – thereby assuming an attendance rate of 85% or conversely an absence rate of 15%.
- Total hours of work per day per direct care staff are assumed to be 8 hours.
- Average staff productivity per day is assumed to be (no more than) 7.04 hours for urban and rural.
- The average daily program length for an Adult day program is 7.04 hours per day.
- Each program is assumed to have 16 members (Urban) and 7 members (Rural) per day.
- Capital requirements are assumed as follows:
 - Each facility is assumed to provide 125 square feet per member for urban locations and 271 square feet per member in rural locations.
