

Arizona Family Caregiver Reimbursement Program

Family caregivers can receive a **50%** reimbursement up to **\$1,000** for home modifications and assistive care technology. Qualifying family member(s) must be **18** years or older and require help with one or more activities of daily living, including toileting, bathing, dressing, grooming, eating, mobility, and transferring.

Could you use some support taking care of a loved one?

You could be eligible for the Family Caregiver Reimbursement Program if you meet the following criteria:

- Caring for a qualifying family member, including a spouse, child, stepchild, grandchild, parent, stepparent, grandparent, sibling, and/or an uncle or aunt, who is **18** years of age or older.
- Caring for a qualifying family member whom requires assistance with one or more activities of daily living.
- Caring for a qualifying family member in their own home or in your home.
- Have not already received a **\$1000** reimbursement from a prior application.



The family caregiver eligibility requirements:

1. You are an Arizona resident
2. You and the qualifying family meet the income eligibility requirements:
 - a. **\$75,000** for a single person or a married person filing separately plus the qualifying family member's combined income
 - b. **\$150,000** for a married couple filing a joint tax return plus the qualifying family member's combined income
 - c. **\$150,000** for a married couple filing a joint tax return when the spouse is the qualifying family member
3. You incurred expenses during the calendar year in which you apply for the FCRP

Examples of home modifications:

- Widening of doorways
- Ramps
- High-rise toilets with handrails
- Accessible shower
- Adaptive switches
- Stair lift
- Grab bars

Examples of assistive care technology:

- Hearing aids
- Eyeglasses
- Adaptive utensils and dentures to facilitate eating
- Shower chair/bench
- Medical alert devices
- Screen readers

Important Requirements:

- Applications must be submitted in the same calendar year for which the purchases were made.
- Applications are reviewed on a first-come, first-serve basis due to limited funding.
- Family caregivers who have previously received the maximum reimbursement of **\$1,000** for a qualified family member are not eligible.
- For reimbursements over **\$600** a 1099 tax form will be provided.
