How to Access CCEI for Training

Frequently Asked Questions

Why do I need to activate a membership with CCEI?

Effective June 1, 2022, *ALL* child care providers that hold a current Provider Registration Agreement (PRA) with DES will be required to utilize CCEI to take the required DES Pre-Service Health & Safety training. The Child Care Education Institute (CCEI), is an approved training agency with the Arizona Early Childhood Workforce Registry ("Registry"), DES, DHS, and FTF that includes required DES Pre-Service Health and Safety training in English and Spanish, as well as courses in other topics to meet annual training needs. Please reference the DES Pre-Service Health and Safety Training Matrix table for the approved courses for DES Pre-Service Health and Safety training.

Do DES providers need to wait 90 days after a hire date to access CCEI to complete Health & Safety training?

No. The memberships are available and ready to be utilized immediately. Please don't delay!

Who needs to access free CCEI memberships for Health & Safety training?

Child Care Providers, staff and volunteers who work for a child care provider holding a DES Provider Registration Agreement (PRA) are required to ensure that all child care staff have completed the pre-service Health & Safety Training. This may include one of the following child care providers:

- DHS Licensed Child Care Centers
- · DHS Certified Child Care Group Homes
- DES Certified Family Child Care Home Providers
- DES Certified Family Child Care In-Home Providers
- Child Care Centers and Family Child Care Providers that are regulated by tribes and military installations

Can I access CCEI to complete Health & Safety training before my hire or start date?

Yes. In order to assist with completion of the required "DES Pre-Service Health & Safety training," free memberships are available to new staff and individuals who will begin work with a child care provider.

Can Volunteers access CCEI memberships and training?

Yes. Any DES child care providers holding a <u>PRA</u> are required to ensure that all child care staff have completed the pre-service Health & Safety Training. The <u>PRA</u> defines staff as: "Staff Member – child care personnel, including volunteers, who provide child care services that are the responsibility of a Provider." For a Volunteers to access the training, they must have a Registry account with the title of Volunteer, and indicate they have employment at the program.

Can DES CCR&R Registered Providers and DES Non-Certified Relative Providers access CCEI memberships and training?

Yes. These providers can also access the training through an account with the Registry.

How do I get a FREE CCEI membership to access training?

1. Go to www.azregistry.org

- 2. Create a Registry account or Login if you already have an account
- 3. Review and update your current employment information, if needed
- 4. Click "CCEI Online Training" at the bottom of the left-side navigation bar
- 5. Select "click here to access the free CCEI online trainings"
- 6. CCEI will open in a new window

How do I find out which training I have completed?

Registry participants can log into their Registry account and select, "My Education and Training Report" and search under Professional Development for the completed Health and Safety Course titles listed on the Training Matrix below.

Registry users identified as Program Administrators, or Multi-site Administrators can view and verify the Health and Safety Compliance status of their staff by clicking on Compliance Detail Report under Program Administration.

I started taking the DES Pre-Service Health & Safety Training Series but did not finish. What CCEI courses do I need to take to fulfill the DES Health & Safety requirements?

Using the Matrix below, you can crossmatch the required courses. For example, if you have taken DES Health & Safety Series Modules 1 - 4 but did not complete Modules 5 and 6, you will need to take HLTH110 and ADM107 through CCEI to be in full compliance with the DES Pre-Service Health & Safety Training requirement.
