

## Attachment 2b Repair and Maintenance of Vending Machines Price Sheet

**Unit rates are inclusive of all costs associated with the provision of the service including, at a minimum:** time spent in the acquisition of parts; salaries; operating costs; staff time; administrative costs; insurance; and other costs associated with the service provision.

Labor rates may be provided Statewide or by County.

Where the Contractor has more than one location, the fifty miles will be calculated from the Contractor's office closest to the repair site. In cases where the Contractor receives two or more work orders to provide services at two or more sites within the same time frame, that are on the same traveling route, only one (1) flat trip charge for that county will be paid.
