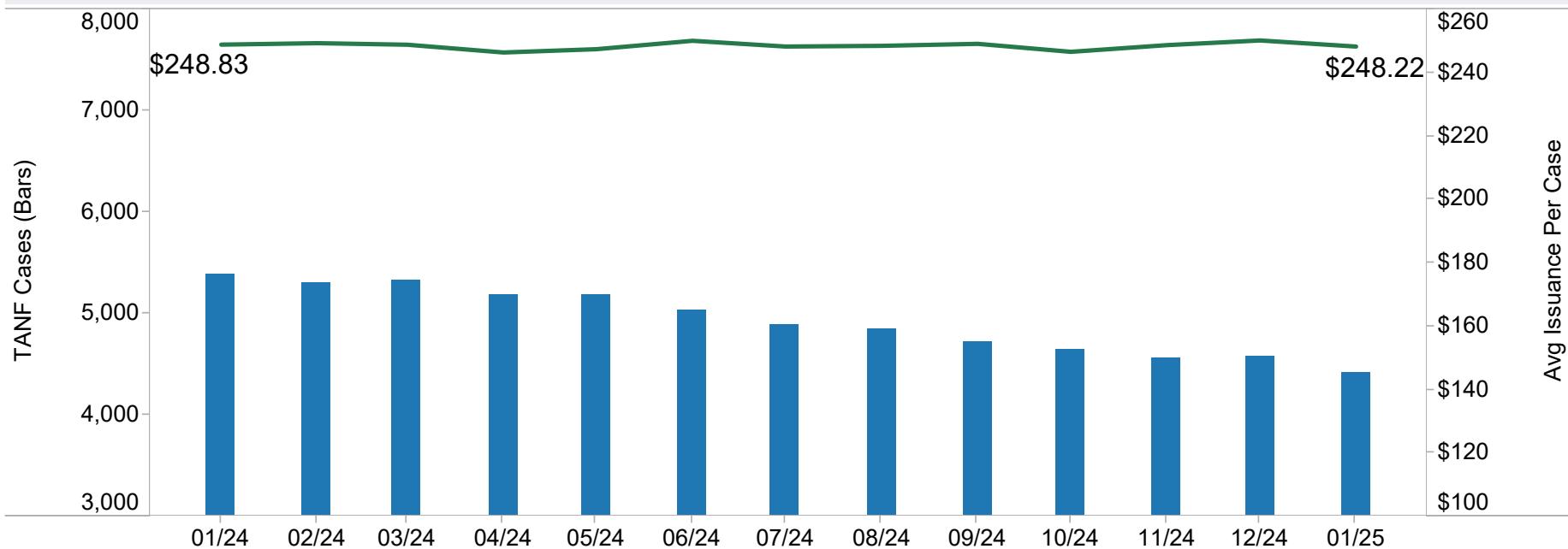

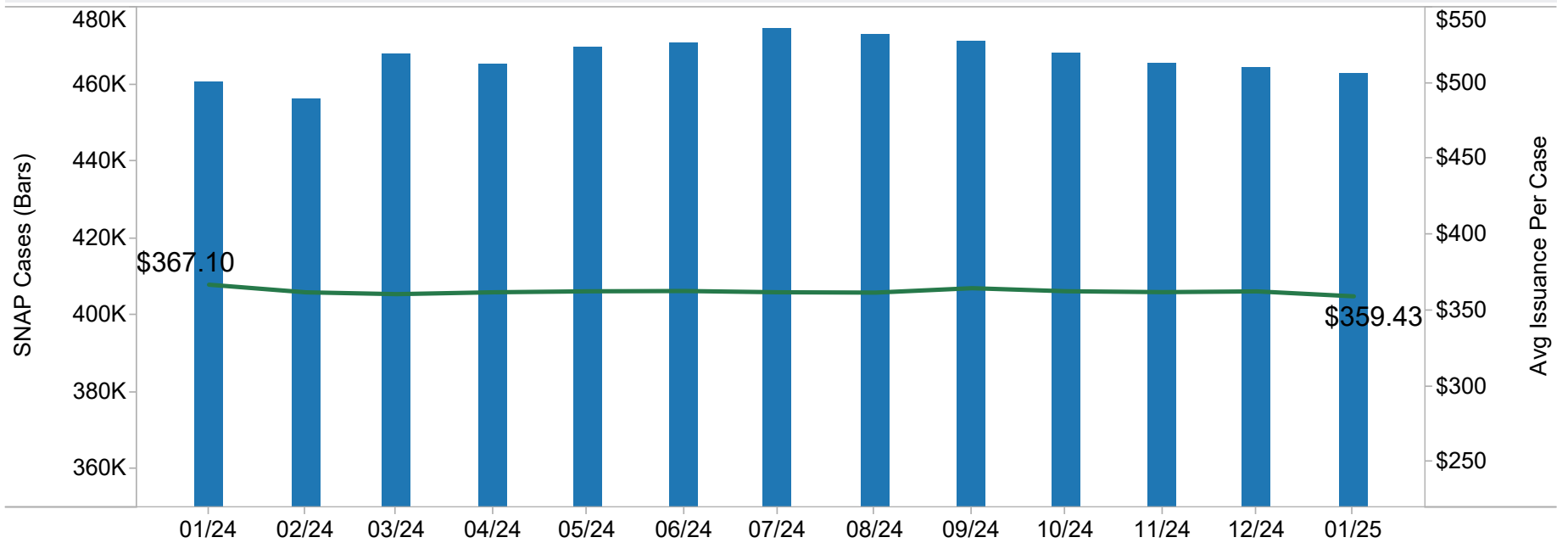

- P-EBT: \$0 issued, 0 families, and 0 children for this month.

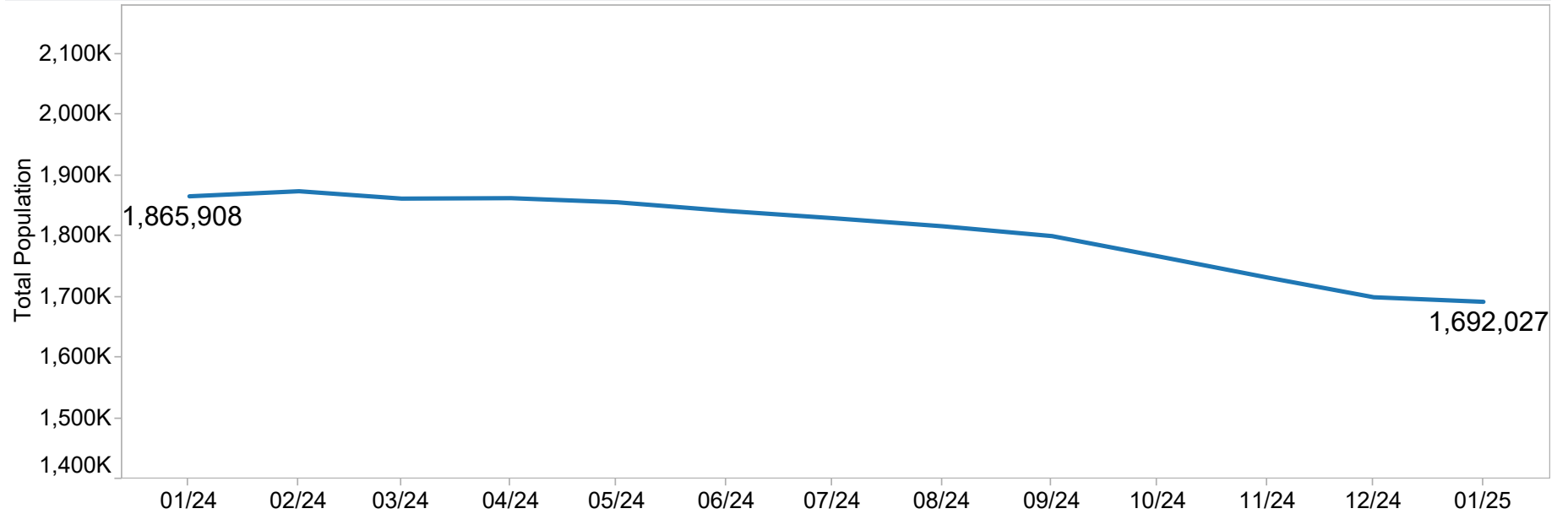
- S-EBT: \$360 issued, 2 families, and 3 children for this month.

- EBT Skimming Monthly Preliminary Data: Between 1/1/2025 and 1/31/2025, 7 SNAP claims were approved for an issued amount of \$2,169.

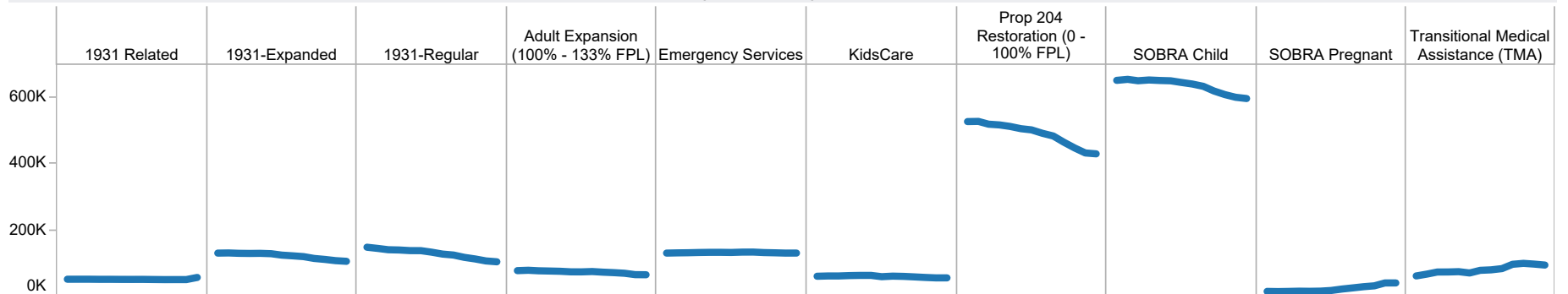
- EBT Skimming Quarterly Final Data: In Q1 (October 2024 - December 2024), 172 SNAP claims were approved for an issued amount of \$74,681.

1 Year Sparkline Population Trend

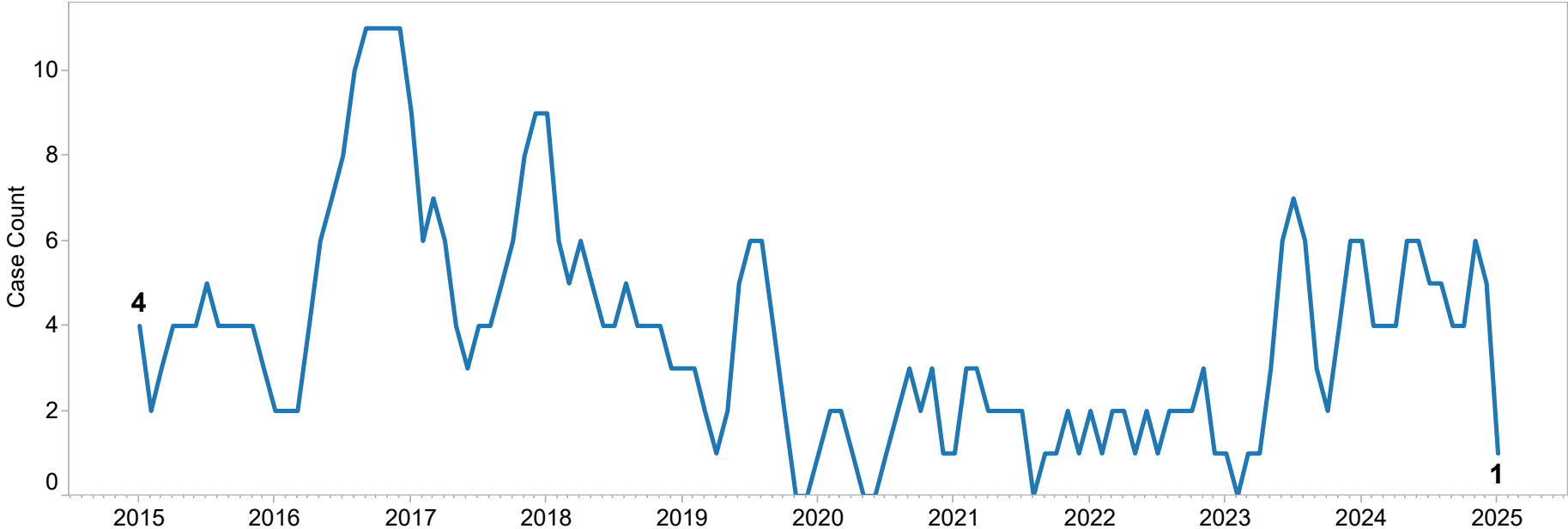

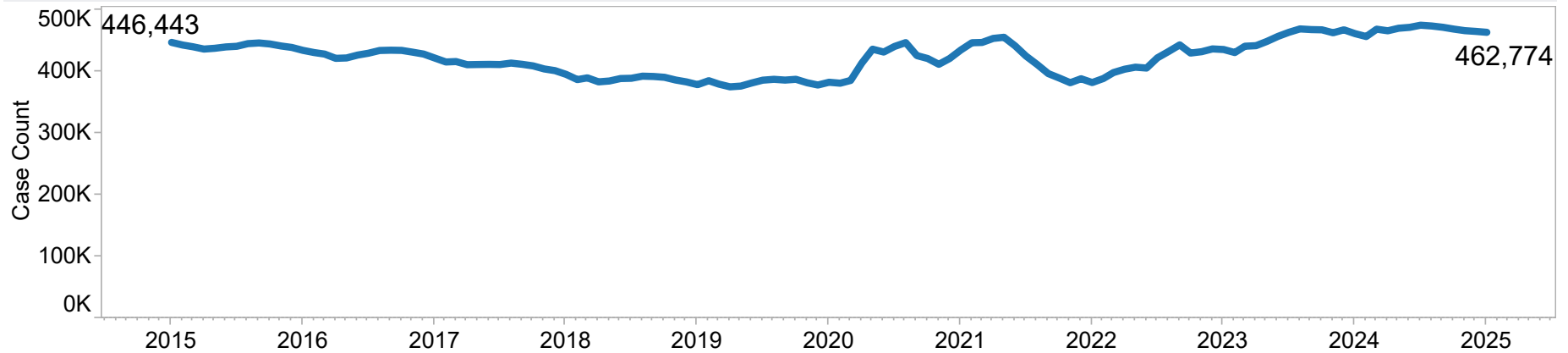

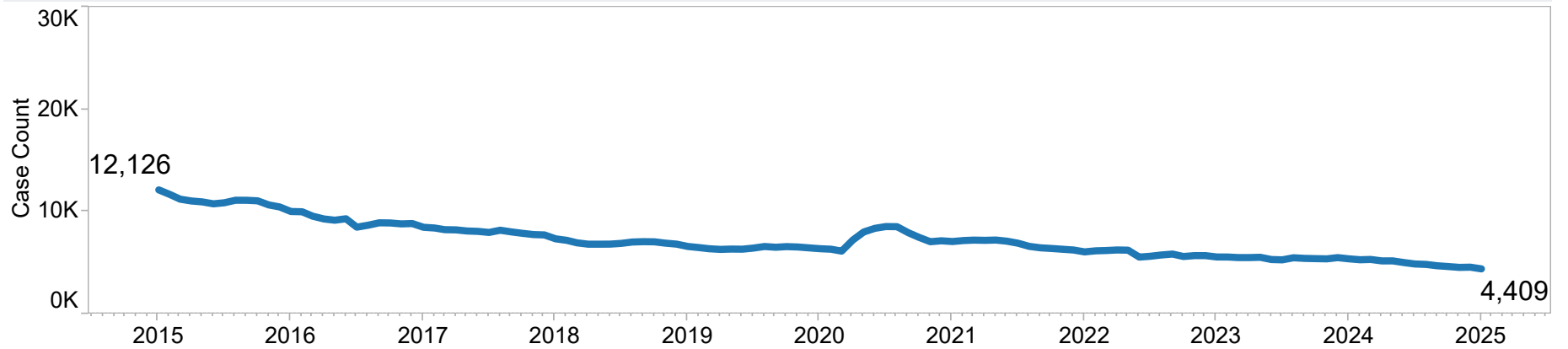
