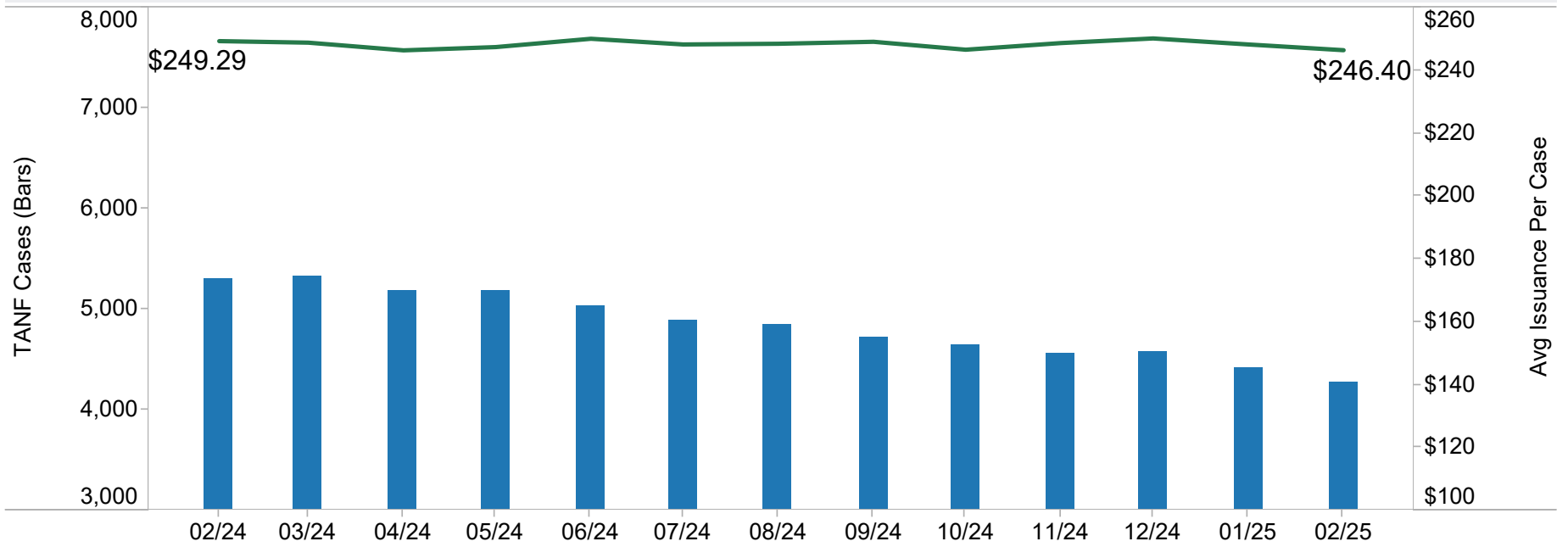

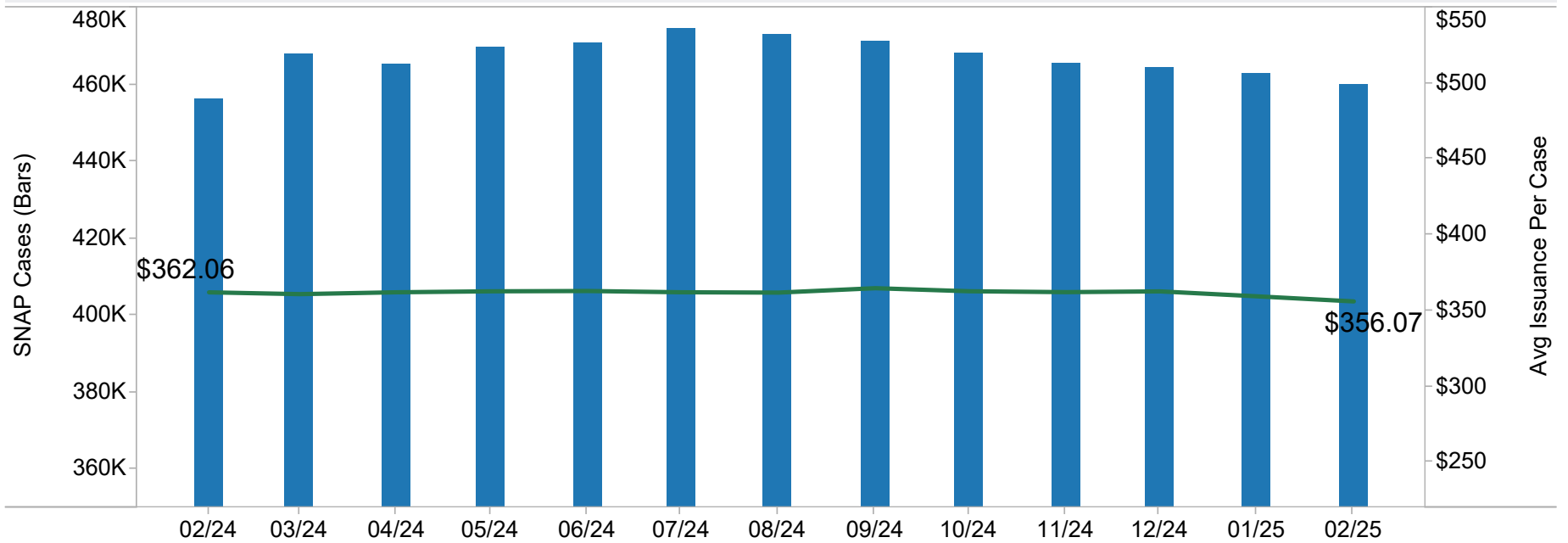

- P-EBT: \$0 issued, 0 families, and 0 children for this month.

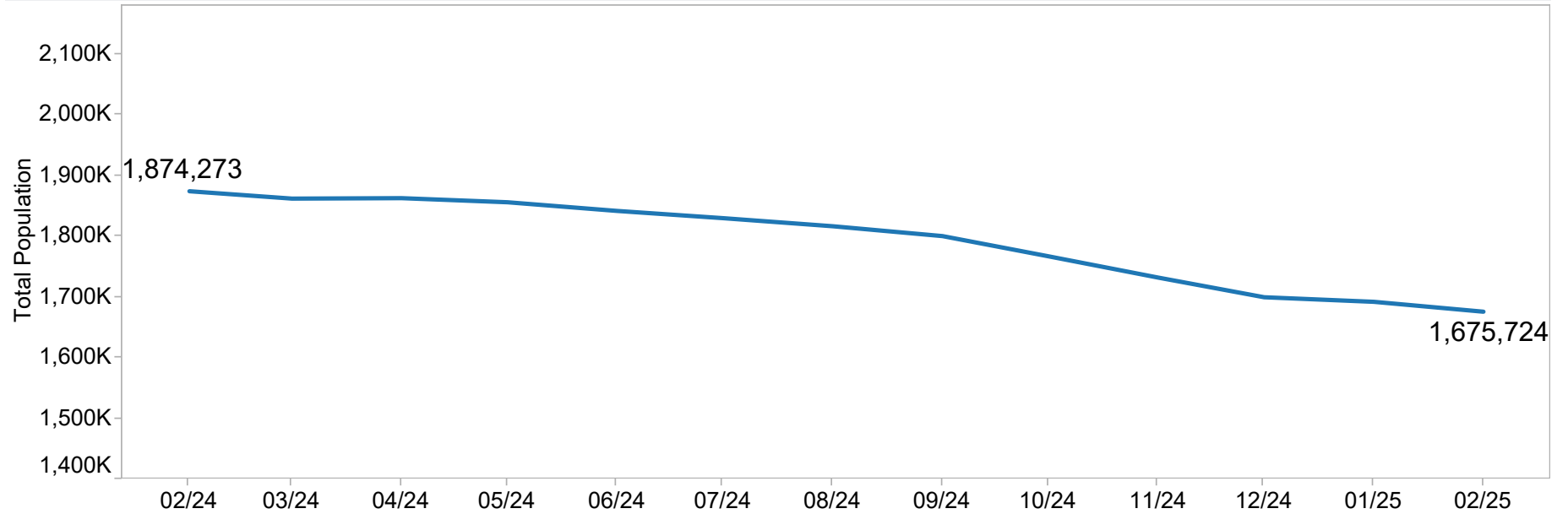
- S-EBT: \$120 issued, 1 family, and 1 child for this month.

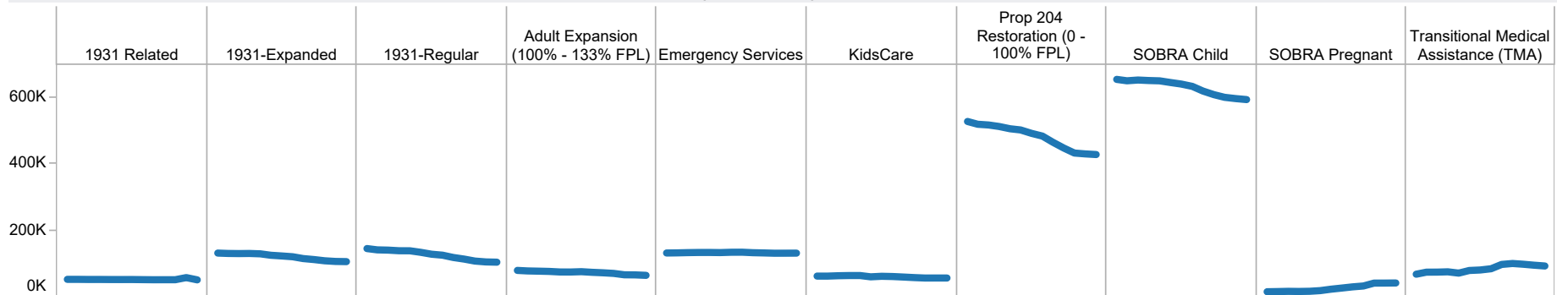

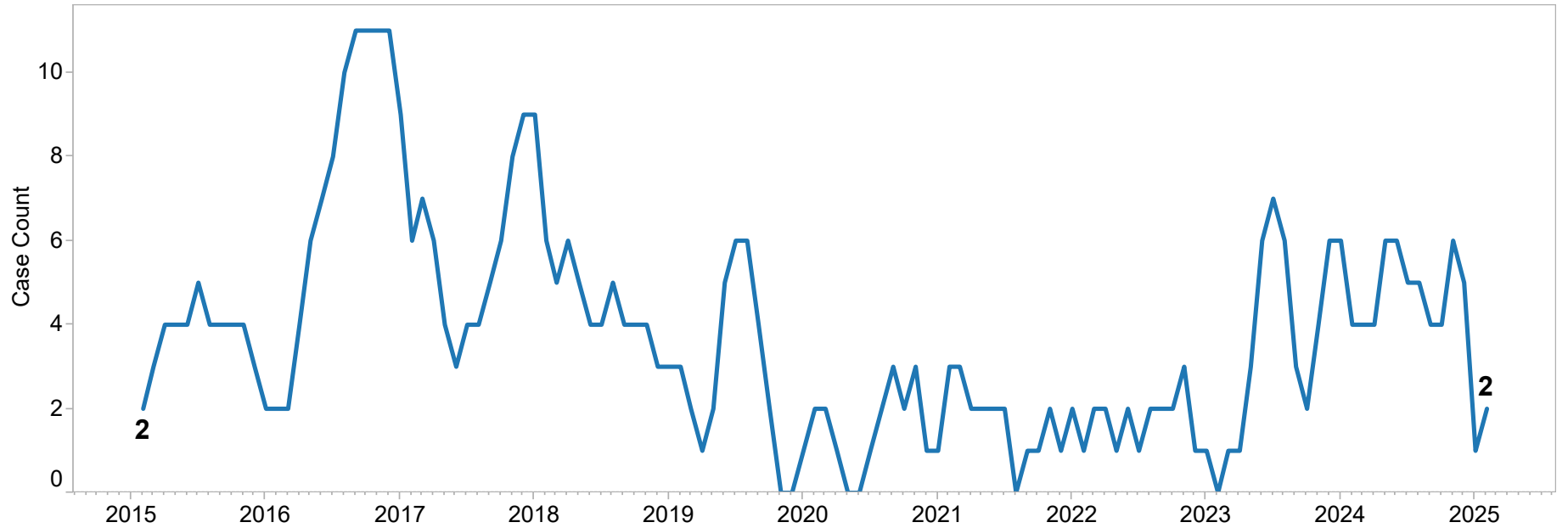

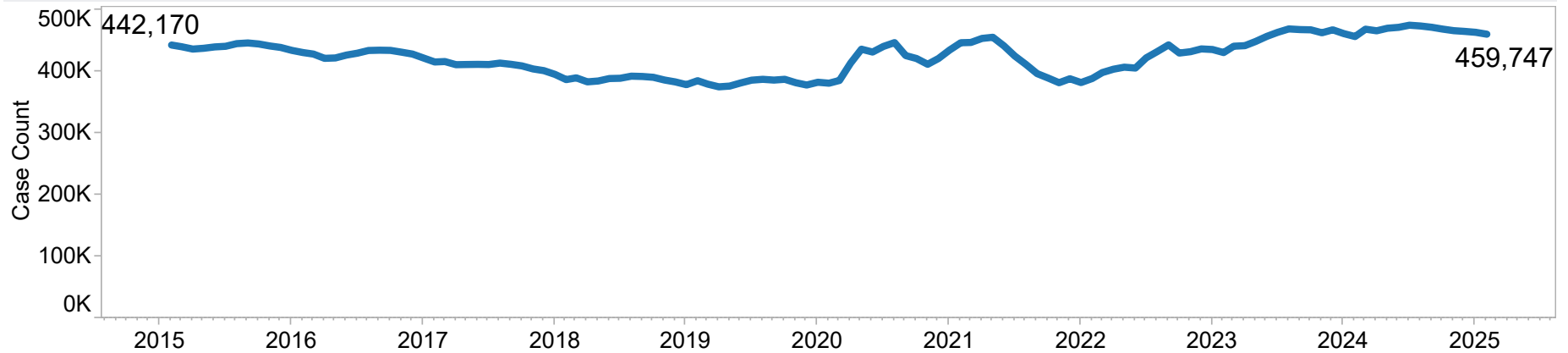

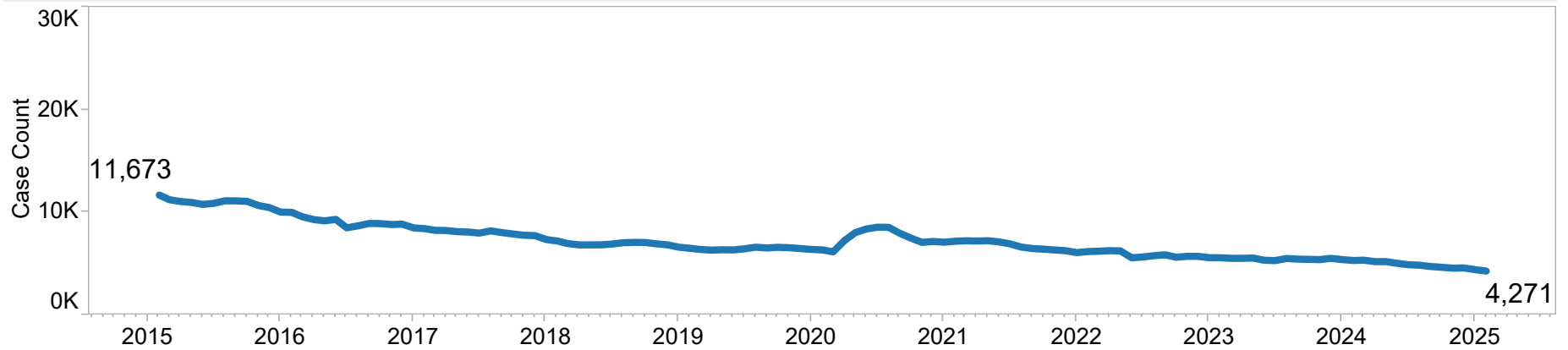
