





FF Coronavirus Response Act - H.R. 6201 adjustments:

- Excludes: P-EBT (Pandemic School Meals Replacement and Child Care Replacement) and S-EBT (Sun Bucks Summer EBT). Program benefits are not SNAP benefits and are excluded. P-EBT/S-EBT families also receiving SNAP are included in families, persons, and children, but benefits issued are excluded.
- P-EBT: \$480 issued, 4 families, and 4 children for this month.
- S-EBT: \$35,087,220 issued, 146,361 families, and 292,391 children for this month.
- On 6/19/2023, DBME started receiving claims for replacement of stolen benefits as a result of electronic theft, known as EBT Skimming.
- EBT Skimming Monthly Preliminary Data: Between 6/1/2024 and 6/30/2024, 80 SNAP claims were approved for an issued amount of \$25,892.
- EBT Skimming Quarterly Final Data: In Q3 (April 2024 - June 2024), 290 SNAP claims were approved for an issued amount of \$98,780.


**Tuberculosis Control


