# DDD RATE REBASE STUDY VENDOR FORUMS

Target Audience - Qualified Vendors and Providers

Transmittal Date - 02/02/2024

The Division of Developmental Disabilities (Division/DDD) is required by statute to perform a rate study every five years, which was last completed in December 2018. The Division has contracted with Milliman, Inc. to perform a new DDD Rate Rebase Study that will be published by ADES and used to evaluate overall HCBS funding levels and to inform future DDD rates.

Consistent with the prior rebase study, the Division has engaged with stakeholders to gather input and feedback throughout the whole process. Stakeholder feedback is critical to best inform the rate modeling process.

Starting on February 8, 2024, Milliman will be conducting vendor forums to discuss the preliminary modeled rate methodology, data relied upon, and comparisons to the prior rate study. These forums will allow vendors to review assumptions and provide feedback on the preliminary rate modeling before being published in the final report. All forums will be held virtually via Zoom, with separate forums for each service type to enable more focused discussions.
