#### **NEW POLICIES**

# <u>Division Medical Policy Manual 1240-F Home Delivered Meals</u>

This policy describes service eligibility, assessment, establishment, and provision of home-delivered meals for Division members who are also eligible for ALTCS.

### <u>Division Medical Policy Manual 1601 Assignment of Support Coordinators</u>

The Division's policy regarding the assignment of Support Coordinators has been moved from the Division's Eligibility Manual (formerly Chapter 500) to this chapter in the Division's Medical Manual. Additional revisions include:

- Clarified the description of Support Coordinator assignment for Members in the care of the Arizona Department of Child Safety, to reflect the assignment occurs in the District where the Member physically resides.
- Added language regarding caseload monitoring.
- Updated formatting to align with Division policy standards.
