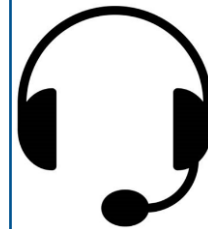

Respite Voucher Program

Two Options: \$599 or \$1200

- Broken into quarterly payments
- \$599 covers 6 months Respite, \$1200 covers one year or Respite.

Consumer directed: family caregiver finds respite provider and makes arrangements

- Paid respite provider can be a family member, friend, or neighbor
- Paid respite provider must not live in the same household
- Can be through an agency or self-employed professional caregiver
- Does not require paid respite provider to have training or certificates

Adult Day Health Center Respite Program

- Up to 96 hours per family in a licensed day center, over a duration of 3-4 months
- Once per calendar year
- Application and Arizona State ID required
- Application is done over the phone, mail, or email
- Referrals from centers/agencies are welcome



Adult Day Health Center Eligibility

Family Caregiver Reimbursement Program

Family caregivers can be reimbursed for 50% or up to \$1,000 for home modifications and assistive care technology

Can receive ALTCS, DDD, VA, AAA as long as the expense was not already reimbursed.

Caregiver submits application, receipts and proof of income and medical need documenting one ADL

Receipts must show payment was made, after January 1, 2020

Multiple applications accepted until \$1,000 cap is reached



Eligibility for reimbursement



Arizona resident

Applicant must be a family member or domestic partner

Care receiver must be 18 years or older and require help with one or more activities of daily living

Modifications may be in caregiver's or care receiver's home

Income limit of \$75,000 for caregiver and care receiver combined (\$150,000 if married)
