## WHAT IS THE ABUSE IN LATER LIFE GRANT

- Background: The Arizona Abuse in Later Life project is funded by a grant from the U.S. Department of Justice Office of Violence Against Women. This project will be coordinated with the assistance of the Community Partners to create a task force made up of agencies that provide services in the areas of abuse investigation, law enforcement, and public administration.
- Grant funds are to be used to increase the effectiveness of the state's response to provide a safe environment for Arizona's senior residents by facilitating coordination and collaboration of the various public and private agencies that serve the needs of seniors.
- Term: October 1, 2020 and terminate on September 30, 2023.

## DIRECT SERVICES/EMERGENCY HOUSING

- Needs Assessment
- Strategic Plan
- Housing Specialist/Area Agency on Aging Region One DOVES Program
- Emergency services (25% of budget) can include up to 10 days of hotel stay (food, clothing, and incidental expenses) for victims of late life abuse (50+) that need a safe place to go in a domestic violence situation. Victims need to stay in Maricopa County, but can reside outside of Maricopa County, and need to contact the Housing Specialist for more information.


