AUTHORIZATIONS TO ADMINISTRATIVE AND SERVICE SITES

Target Audience - Qualified Vendors and Providers

WellSky requires that vendors bill under the site to which the service authorization is assigned, either the "parent" site (Administrative AA site) or, if applicable, the "child" site (service location site). The Division is working on an initiative to ensure service authorizations in Focus are assigned to the appropriate administrative or service location site.

This initiative will provide consistency for how Support Coordination staff assign authorizations in Focus, and Vendors will know where to find their authorizations and at what level to bill (either parent site or child site). The Division has developed the table below outlining which services are authorized to a vendor's administrative or service site in Focus.

Qualified Vendors must continue to enter administrative and service sites in the Contract Administration System (CAS) as currently required and ensure the services associated with each site are assigned to the site. Instructions on managing administrative and service sites can be found in the DDD QVA User Guide and Manual.
