- Transition Committee (Stephanie Collier/Chantelle Curtis)
 - There are two separate groups that have been meeting. There is nothing needed from the Executive Committee
- Fiscal Committee (Amber Neubauer/Lisa Casteel)
 - Met yesterday and is creating a subcommittee to help investigate other funding sources to offset some of the AzEIP costs. Looking into additional grants and what other states do
- Family Engagement Committee (Jaime Pack-Adair(resigned new Chair needed)/Tanya Goitia/Annie Converse)
 - O This committee is in need of a new chair

- O Jamie Pack-Adair and Britany Miller resigned. The Next Committee meeting will be on March 9, 2023. The help needed is to figure out how to determine a new chair
- O Working on the review of the Child Rights brochure. We will work on the Family Guide to funding. Will develop supplemental FAQ documents
- There were several submissions for the family story
- Need help with the Chair and membership
- Lisa Vallee reached out to Neil Wintle from Raising Special Kids to see if they had any suggestions for ICC
- The Family Engagement Committee consists of Sarah Green, Laurie Shook, Shauna Anderson, John Molina, Janet Viloria, Nohemi Ortega, and Neil Tiff. Attendance and participation have been good.
- Lana Graber has reached out to Sarah Greene to see if she will chair the committee. Arial has taken on the Development Committee
- O Janet Viloria and Nohemi Ortega would be a good fit for the Family Engagement Committee
- Do not have representation from our service-providing agencies
- O Lori Shook and Sarah Greene have been covering the ICC media
- O We would like to have a committee member from a contractor, DDD, and ASDB
- There would be an appointed committee member that does not need to be part of ICC. They will fill out an application and get approval from the chair
- We need more service-providing agencies to participate
- The committee meets monthly when possible if not at least quarterly
- O The next meeting will be on March 9 2023 from 9:30am to 11:00am
- Have a family story for the next meeting
- o The next ICC Committee meeting is March 24, 2023
- Development Committee (Ariel Sansom/Erica Mieles)
 - The next meeting is March 21, 2023, and will be going over the letters
 - Would like a change to the bylaws and have a chair and a vice chair. At the next ICC Council Committee meeting will come up with what they would like to present. It will be reviewed and put in the bylaws
- AzEIP Updates (AzEIP)
 - Lisa Vallee is the new Community Relations Liaison, she will be working in collaboration with Lana Graber
 - We have an ICC email inbox for correspondence. It is <u>AZICC@azdes.gov</u> and Lisa Vallee will be monitoring the inbox
 - The Arizona Part C Grant application draft has been posted for comments. OSEP requested clarification on some items. There is a presentation happening at the EI/ECSE Summit describing what collaboration looks like with Part C and Part B
 - We will have a Tribal Liaison starting soon. They will be working with the Tribal communities. It is a shared position that will be shared with the Child Care Division
 - At the next meeting, we will need to map out what we need for the State Steminic Plan
 - The Leadership Conference will be in July in Virginia. We need to determine who from ICC will be attending
 - O DEC meeting in Minnesota, from November 28, 2023, through December 1, 2023. We need to identify and finalize the budget for the ICC. Chantelle will present on CSPD
 - o Part B and Part C will be presented at the EI/ECSE Summit
 - The APR/SPP was submitted on February 1, 2023
 - Angie Rogers is the new DES Director
 - o EI/ECSE Summit is on March 2, 2023, and March 3, 2023. AzEIP will be sponsoring families that would like to attend. They should contact Chantelle Curtis if they are interested in attending

- AzEIP is in the process of entering into an MOU with Oregon State Health Institution University around the project ASCEND
- Department of Health Services shared information about sensory screenings that will be provided starting in March. There will be free training for hearing and vision screenings. AzEIP will provide information about what support AzEIP office will be providing
- There will be more information on AzEIP about home based / in-person services. There will be more information coming out from the AzEIP team
- O The OSEP Leadership Meeting is in person but they are offering it virtually. It would be helpful if someone from ICC attends. Suzanne Perry on the ICC will be attending. If anyone would like to attend in person, AzEIP sponsors them
- CSPD is directed by AzEIP and updates will be shared
- Have not done an open meeting law presentation for the council in some time. Lisa Vallee will collaborate with AzEIP on this topic
- Lisa Vallee has done a presentation on recycled play to parents. She discussed how to use household items for child play as a possible educational topic. There are various items that can be used for play. Caroline would like to invite more family participation to the meetings
- There was information discussed on New Song which is New Song Center for grieving children.
 It is through the hospice of the valley. Tanya Goitia will share that they offered to do a presentation about their program

 - Lana Graber will email the service providing regarding a need for them to collaborate
