- 6. AzEIP Updates- Alicia Amundson, Quality Improvement Manager, provided overview
 - OSEP determination- two years in a row, Meets Requirements. Congratulations AzEIP providers and all.
 - AzEIP realignment to the DES Office of the Director, announcement went out to public.
 - Comprehensive System of Professional Development review
 - COVID-19 task force developed to ensure stakeholder feedback, El leaders, DDD, ADSB, family participate. First task was to hold Family listening sessions. Current and future focus will be to give guidance in the interim on home visits when they resume.
 - DEC/aRPY Ambassador update- increase knowledge of DEC recommended practices, connect with service providers and families to all available resources. There are so many resources already available, we don't have to recreate.
- 7. ICC Member Updates
 - Suzie, Ade update: ADE Early Childhood Special Education Unit
 - Now housed in Exceptional Student Services section and working closely with Alissa Trollinger, Deputy Associate Superintendent of ESS
 - Preschool transition- for the most part schools working diligently to transition children with EI services by 3
 - 8/17 schools were expected to begin services for children with IEPs
 - Inclusion- working as closely as possible with schools to ensure inclusion to the extent possible during COVID (in-person, distance learning, or combo)
 - Assessment process and expectations have not changed
 - Question: If Part B districts can decide what model is best, why not Part C?
 - Alicia: Part C receives direction from OSEP, responsibility to provide equitable services within all programs and regions.
 - Alissa: Part B- the governor's executive order allows all districts and charter schools to operate based on their own decisions
 - o Chris, Department of Child Safety at CMDP
 - Integrated Health Plan contract awarded to Mercy Care Plan effective 4/1/21
 - CMDP will oversee the integrated health care provided by Mercy Care and partner with Mercy Care to provide health care for children in foster care
 - o Judie, AHCCCS

- AHCCCS continues to provide services through tele-health/telemedicine to allow children and families to receive support and maintain relationships with providers

Public Comment Shared

The Arizona Association of the Deaf continues to be concerned about language acquisition for Deaf, Hard of Hearing and Deaf Blind infants and toddlers in Arizona.

The Visual Communication and Sign Language Checklist (VCSL) is the world's first and only standardized tool for measuring ASL growth and development for Deaf and Hard of hearing children birth to 5. We advocate that VCSL be used as an assessment tool by providers.

We are also excited to share three amendments to 2020-2023 EHDI that:

- 1. Requires language acquisition assessments.
- 2. Requires families to receive services in both oral and visual modalities.
- 3. Requires provision of Deaf Mentors to families.

Deaf, Hard of Hearing and Deaf Blind children will be able to overcome the consequences of language deprivation by assessing language, providing oral and visual modalities and providing Deaf Mentors that can lead to brighter future for D/HH/DB individuals.
