Once budgets have been submitted with the adjustments published in these alerts, contract amendments will be processed for billing purposes retroactively, if needed, to allow for invoicing for services beginning July 1, 2026.

The tribes may begin spending against these additional lines of funding beginning July 1, 2026. However, DAAS cannot reimburse those expenses until an executed contract amendment is on file.
