SFY-21-1A

Older Americans Act Title III and VII for SFY-2021

The Division of Aging and Adult Services (DAAS) received an overall increase of \$755,784 for Older Americans Act Title III and Title VII collectively in the FFY 2020 grant awards from the Administration for Community Living. A full 100 percent of the FFY 2020 overall increase was placed into the SFY 2021 allocation. Had the changes been received in SFY 2020, ¾ of the overall increase would have been placed in SFY 2020 and ¼ of the increase would have been placed in SFY 2021.

The following changes occurred in Title III and Title VII in the following titles and subparts:

- an increase of \$153,616 in III-B
- an increase of \$204,621 in III-C1
- an increase of \$199,029 in III-C2
- an increase of \$26,876 in III-D
- an increase of \$147,040 in III-E
- an increase of \$5,956 in VII-Elder Abuse
- an increase of \$3,297 in VII-Federal Ombudsman

Nutrition Services Incentive Program (NSIP) for SFY-2021

Attached are the initial allocations that identify the contract planning levels for NSIP for each respective Planning and Service Area for State Fiscal Year (SFY) 2021.

The allocations are based on the Federal Fiscal Year (FFY) 2020 grant and on the meals served by the Area Agencies on Aging (AAAs) during FFY 2018 and are subject to revisions during SFY 2021. The Division of Aging and Adult Services expects to receive the FFY 2021 grant award in April 2021, and if so, the revised allocations will be included in the May ALERT.

NSIP funds may be used to pay for any client receiving home delivered meals or congregate meals.

Unexpended dollars at the end of the fiscal year are allowed as carryover into the next fiscal year. Carryover dollars must be expended prior to utilizing any new allocations.

SFY-21-7A

State Health Insurance Assistance Program (SHIP) for SFY-2021

The Division of Aging and Adult Services (DAAS) received a supplemental award in the amount of \$75,905 from the Administration for Community Living (ACL) for the budget period of July 1, 2020 through March 31, 2021 for the State Health Insurance Assistance Program (SHIP). This award is in addition to the initial award in the amount of \$4,358,785 for the project period of April 1, 2020 through March 31, 2025 for SHIP.

Background

- 1. Enhancement and expansion of local program capacity to provide enrollment information, counseling, and assistance to reach and assist all Medicare eligible beneficiaries, with an emphasis on those who:
 - Are disabled, specifically beneficiaries who are under 65 years old.
 - Are low income, especially those likely to be eligible, but who have not yet applied for Medicare Prescription Drug Low Income Subsidy (LIS); and/or
 - Speak languages other than English, have literacy challenges, and beneficiaries living in intensely urban or frontier rural areas.
- 2. Expansion of existing partnerships with other public and private organizations involved in providing outreach, counseling, and enrollment assistance.
- 3. Increase internet access to local counselors and local counseling sites.
- 4. Utilize the SHIP Tracking and Reporting System (STARS) to demonstrate achievements in providing services to Medicare beneficiaries by established deadlines and in accordance with performance measures requirements.
- 5. Participate in the Administration for Community Living (ACL) and Center for Medicare and Medicaid Services (CMS) outreach events, by providing support for the ACL and CMS Regional Office community-based events.

Funding

Base funding is allocated by the percentage of Medicare eligible beneficiaries per county.

The Department of Economic Security, Division of Aging and Adult Services (DES/DAAS) has received a grant award for the Medicare Improvements for Patients and Providers Act (MIPPA) in the amount of \$451,060 [Priority 1 for SHIPs \$218,114], [Priority 2 for AAAs \$120,242], and [Priority 3 for ADRCs \$112,704] from the Administration of Community Living (ACL) for the budget period of September 30, 2020 through September 29, 2021.

The goal of the MIPPA project is increase statewide awareness to Medicare beneficiaries, their families and caregivers, of the Low-Income Subsidy (LIS) Program, Medicare Savings Program (MSP and Medicare Prescription Drug Coverage (Part D), as well as Medicare prevention and wellness benefits, by building strong local and state coalitions to conduct group outreach and education about these programs and to provide one-on-one application assistance to beneficiaries that meet eligibility requirements through the Arizona State Health Insurance Assistance Program (ASHIP), the Area Agencies on Aging (AAAs) and the Aging and Disability Resource Consortium (ADRC).

Overall Program Measurable Outcome(s) for September 30, 2020 through September 29, 2021:

- Priority 1: The ASHIPS will provide enrollment assistance to 2,000 Medicare beneficiaries for LIS and MSPs, and 500 Medicare Part D beneficiaries who may be eligible for LIS and MSP;
- Priority 2: The AAAs will provide enrollment assistance to 1,000 Medicare beneficiaries for LIS and MSP, and 500 Medicare Part D beneficiaries who may be eligible for LIS and MSP;
- Priority 3: The ADRCs will provide enrollment assistance to 500 Medicare Part D beneficiaries; and
- Priority 3: The ADRCS will conduct a minimum of 21 outreach events to individuals who may be eligible for Medicare Part D.

Objectives for this grant term are focused on the following project activities:

- 1. Target under-served populations and secure additional key community partner agencies for this project.
- 2. Develop a coordinated plan for outreach activities, presentations, and designated enrollment events for this project, focusing on disease prevention and wellness as well as targeting beneficiaries as outlined by ACL MIPPA Performance Measures.
- 3. Provide on-going technical assistance to key partners and stakeholders to help increase beneficiary understanding and awareness of LIS, MSP, and Medicare Part D among targeted populations.
- 4. Prepare MIPPA related outreach materials in accordance with ACL requirements.
- 5. Launch of outreach, media campaigns, and enrollment assistance activities.
- 6. Monitor local project progress, data accuracy and performance goals.

Allocations are based on the percentage of Medicare eligible beneficiaries residing in each service delivery area. These percentages are based on the most current data reflected in the SHIP Tracking and Reporting System (STARS).

- Service units should be reported and billed as the number of client contacts that received enrollment assistance for LIS and MSP that resulted in the submission of an application per billing month at \$200.00 per application.
- Service units may also should be reported and billed for the number of client contacts that received enrollment assistance for Part D that resulted in submission of an application per billing month at \$200.00 per application.
- The agencies will conduct outreach events for eligible individuals and may bill \$1,000.00 per outreach event, up to ten (10) events.
- The agencies must report all program activities related to the MIPPA project in STARS and code accordingly to Priority 1, 2 or 3.

The report will also include the number of LIS, MSP and Part D applications submitted, the number of outreach events held, and educational outreach products produced and disseminated.

Lifespan Respite Care Grant: Day Center Respite Program

The Department of Economic Security, Division of Aging and Adult Services (DAAS), through the Administration for Community Living, was awarded funding for the Lifespan Respite Care Continuation Grant. The Continuation Grant period is from **September 1, 2020 – August 31, 2023.** Funds will be used to strengthen the Lifespan Respite Care Network in Arizona, continue the provision of respite care services, and coordinate the work of the Lifespan Respite Care Advisory Committee.

Area Agency on Aging Allocations

A portion of the grant funds will be utilized to continue the Adult Day Health Center (ADHC) Respite Program coordinated by the Arizona Caregiver Coalition. The following allocations are made to participating Area Agencies on Aging for respite care services provided by ADHCs within this program. Ten percent (10 percent) of the Continuation Grant allocation may be used for administrative fees.
