The Department of Economic Security, Division of Aging and Adult Services (DES/DAAS) received a grant in the amount of \$225,922 for Priority 1 SHIPS from the Administration of Community Living (ACL) and has allocated \$210,277 to AAAs for contractual services during the grant period September 1, 2021 through August 30, 2022.

This ALERT awards the remaining two months of July and August 2022 in the amount of \$34,873 for this grant period for FY 2023 and is in addition to the budget already allocated for October-June for FY 2023.

AAAs should submit invoices for the two-month period of July and August 2022, by the end of November 2022 to ensure reimbursement to AAAs.

All Program Terms and Conditions and Reporting Requirements stated in the September 30, 2022 ALERT SFY-22-11C remain in effect.

**PROGRAM FUNDING:**
