# Introduction and Scope

The Arizona Department of Economic Security, Division of Developmental Disabilities (the Division) contracted with Guidehouse to conduct an annual analysis of the adequacy and appropriateness of payment rates for home and community-based services (HCBS) for individuals with a developmental disability, as required by A.R.S. 36-2959<sup>1</sup>.

The department shall contract with an independent consulting firm for an annual study of the adequacy and appropriateness of title XIX reimbursement rates to service providers for the developmentally disabled program of both the Arizona long-term care system and the state only program. The consultant shall also include a recommendation for annual inflationary costs. Unless modified in response to federal or state law, the independent consulting firm shall include, in its recommendation, costs arising from amendments to existing contracts.

Specifically, Guidehouse executed the following analyses:

- Analyzed five (5) years of claims files, State Fiscal Year (SFY) 2019-2023<sup>2</sup>
- Reviewed utilization, payment, and provider data by year and service
- Compared overall Qualified Vendor networks to providers delivering services identified through the claims files
- Compared overall unassigned authorizations to providers delivering services identified through the claims files

Throughout the analysis process, Guidehouse took the following key elements into consideration:

- Impact of changing rates on utilization, particularly rate changes that went into effect on 1/1/2023
- Potential provider shortages
- Impact on the service delivery to members

In the rate analysis, Guidehouse evaluated the network, users, payments, and providers, as well as rates of inflation; and developed the written and graphical findings on the adequacy and appropriateness of the Division's HCBS Provider rates that follow in this report.

While reviewing the claims for services rendered during the time period State Fiscal Years (SFYs) 2019 through 2023, there were eighty-three unique services identified in the data. Guidehouse grouped these unique services into seven major service categories which includes:

- Residential Services
- In-Home Supports
- Day Treatment
- Employment
- Transportation
- Professional, Nursing
- Professional, Therapy

Guidehouse excluded all other services for purposes of this analysis. Although these are services are covered services, they are not part of the standard services delivered by providers

under the Request for Qualified Vendor Application (RFQVA). This analysis focused solely on the RFQVA provider services.

In addition, Guidehouse grouped the counties in Arizona into six different regions for purposes of this analysis. The regions are defined as:

- Maricopa County
- Pima County
- Flagstaff
- Northern Counties excluding Flagstaff (Apache, Coconino, Mohave, Navajo, Yavapai)
- Central Counties other than Maricopa (Gila, Pinal)
- Southern Counties other than Pima (Cochise, Graham, Greenlee, La Paz, Santa Cruz, Yuma)

Guidehouse felt it was important to look at Maricopa and Pima County individually as they are the largest counties by population and have distinct characteristics. Flagstaff was also broken out separately as the Flagstaff Proposition sets a different minimum wage than the rest of the state. Guidehouse excluded services for clients that are considered Out of State for purposes of this analysis.

# Provider Rate Reimbursement Adequacy Assessment Certification

In assessing the adequacy of the Division's HCBS rates, Guidehouse examined five years of claims data (SFY2019-SFY2023), alongside Unassigned Authorization and Qualified Vendor data. As part of the determination of rate adequacy, Guidehouse reviewed metrics such as user and unit trends by service category over the last 5 years. We also reviewed payments by service, payment per user, payments per provider by service, as well as additional review of the providers in the state to determine rate adequacy. This also included a rate review compared to the benchmark rates to determine if they were in line with what would be expected in an adequate rate (rate comparisons are shown later in this report in the sections analysis by service category).

Due to high inflationary periods since the last rate study, Guidehouse felt it was an important step to bring wages forward to CY2023 for benchmarking purposes. In order to do this, Guidehouse used the 2020 rate study models and updated the wages from 2020 levels to 2023 levels. Guidehouse used the percent change of the minimum wage between the two time periods. Flagstaff wages received a 29.23 percent increase, and the other wages received a 15.42 percent increase. Also, all wages were rounded to the nearest penny. This methodology was applied to both the worker's wage and the supervisor's wage of each rate model. In this report "Benchmark" or "CY2023 Benchmark" is referring to the outputs of this exercise.

Guidehouse observed within the Division's claims data that total payments to providers increased by \$326 million in SFY2023, which represents a 21.07 percent increase from SFY2022. This increase was expected as the Division implemented updated rates. These similar growth trends extended to the number of providers serving members with developmental disabilities as well as the number of users receiving services.

Based on the service payment and utilization observed in the service categories (as detailed throughout the report), Guidehouse certifies the current rates paid by the Division are adequate reimbursement to Arizona providers for delivering the services currently covered. It should be noted that not every individual measure may indicate a specific rate is adequate for the total program, Guidehouse believes the rates meet the criteria of being adequate based on the analysis included in this document.

Guidehouse determine that anything below 85 percent of the benchmark or below the current minimum wage should be looked at for future increases. When reviewing the rates to the benchmark rates, Guidehouse did observe some current rates that fell below an acceptable benchmark percentage which does cause some concern. Some of those include:

- Therapy Services
  - Occupational Therapy
  - Speech Therapy
  - Physical Therapy
- Employment Services
- Habilitation, Group Home
- Habilitation with Music Therapy
- Homemaker

Minimum wage laws in Arizona require an increase of the minimum wage yearly by utilizing the Consumer Price Index for All Urban Consumers (CPI-U) All Items, August to August trend.

• "The increase in the cost of living shall be measured by the percentage increase as of August of the immediately preceding year over the level as of August of the previous year of the consumer price index (all urban consumers, U.S. city average for all items)"<sup>3</sup>

In accordance with A.R.S. § 23-363(B), Guidehouse suggests yearly updates to the wage portions of the rate models using the same methodology, which is trending forward wages by the CPI-U All Items, August to August trend. This will help keep the rates in line with changes to cost of living. It is Guidehouse's understanding that the Division is currently performing a rate rebase where these issues could be resolved.

# **Overall Analysis of Utilization, Users, Payment, and Providers**

# Approach and Criteria Used in the Examination

In this section, we discuss the criteria our team used to complete this review and our analysis of overall utilization, users, payments, and providers. These analyses inform our overall assessment on the adequacy and appropriateness of the reimbursement rates for State Fiscal Year 2023.

While the State of Arizona Revised Statutes do not fully detail how this review should be conducted or define what "adequate and appropriate" rates are, consistent with previous rate certification reviews, Guidehouse used Section 1932 of the Social Security Act and 42 CFR 438.206 of the Medicaid managed care regulations as the basis for this rate assessment. It should be noted that the Division of Developmental Disabilities is, in effect, a managed care organization contracted with the Arizona Health Care Cost Containment System (AHCCCS) to provide physical health, behavioral health, and HCBS to individuals with developmental disabilities across Arizona.

In conjunction with the utilization analysis, our team considered the impact of inflation on the provider reimbursement rates, while also considering how the COVID-19 pandemic might have had an influence on our analysis for previous years of data.

For the purposes of our analyses, our team used SFY2019 as the benchmark year because it was the earliest year in the available claims data. Our analyses included comparisons of current year data to the previous year, SFY2022.

# **Users and Unit Analysis**

An examination of total users and total units provides a baseline for the most common services used and those with the most utilization. In the figures that follow, bars represent totals for each SFY by service category and the percentages are the percent change from the previous year.

Guidehouse's analysis showed that of the highest used services most had an increase in users between SFY2022 and SFY2023. In-Home Supports and Day Treatment showing the largest increases of 7.47 percent and 4.70 percent, respectively. It is also noted that after significant decreases during the pandemic, Transportation Services users have started to increase again in SFY2022 and SFY2023. Overall, the users base increased by 4.81 percent, from 33,754 users in SFY2022 to 35,376 users in SFY2023.




Figure 1. Total Users, by Service Group and Year, SFY2019-SFY2023





Figure 2. Total Units, by Service Group and Year, SFY2019-SFY2023

As seen in Figure 2 above, majority of the service categories had an increase in units between SFY2022 and SFY2023, with In-Home Supports and Day Treatment showing the largest increase. During the pandemic, it is likely that the services provided in the home would increase and the Day Treatment and Employment Services would decrease. We are now seeing a shift back into the Day Treatment in SFY2022 and SFY2023. It is also noted that after significant decreases during the pandemic, Transportation Services have started to increase again in SFY2022 and SFY2023. However, Professional Nursing did show a decrease of 9.58 percent year over year. Total units across all services increased 9.08 percent, or about four million units

between SFY2022 and SFY2023. Between SFY2019 and SFY2023, total units delivered increased by about 7.6 million units, a 19.13 percent increase.

Overall, users and units increased from SFY2022 to SFY2023 by 4.81 and 9.08 percent, respectively. As such, we observed an increase in total units per user.

# **Payments Analysis:**




Figure 4. Total Payments, by Service Group and Year, SFY2019-SFY2023

An analysis of total payments and total payments per user allows for an examination of provider rate reimbursement changes that occurred in SFY2023 and its impact on utilization. As shown in Figure 4, most of the service categories show expected increases that correlate to increase in units in Figure 2. Residential, In-Home Supports, and Day Treatment showed increases in total payments. Only Professional Nursing show a decrease in SFY2023 of 1.59 percent.




Figure 5. Total Payments per User, by Service Group and Year, SFY2019-SFY2023

As expected with the increase in payments, we see a significant increase in payment per user with 10 percent plus increases to all services with the exception of Professional Nursing and Professional Therapy showing slightly more moderate increases. Total payments per user increased 15.52 percent between SFY2022 and SFY2023, a \$7,115 increase. Overall, total payments increased 21.07 percent between SFY2022 and SFY2023, a \$326M increase.

# **Provider Analysis:**

Guidehouse also examined changes in the provider landscape in SFY2023, as changes in provider levels are a key indicator in rate adequacy. We examined the total number of providers with a claim of in scope services to understand trends in provider participation across each service category, as well as the trends in payments per provider. We observed that the rate increases in past years seems to have been met with an increase in total providers, except for services with more skilled workers like Professional Nursing and Professional Therapy where these skilled services may require a longer timeframe to acquire more providers. Professional Nursing Services has remained flat over the last two years indicating there may be a shortage in nursing services available. As noted later in the Professional Nursing Services wage summary the wages have increased significantly compared to benchmark, but it does not seem to be bringing more providers into the space. Professional Therapy Services had been decreasing for the previous 4 year but showed a slight increase of 1.09 percent in SFY2023.





Figure 6. Total Providers, by Service Group and Year, SFY2019-SFY2023

Payments per provider increased for all services with the exception of Professional Nursing that showed a small decrease of 1.59 percent, as payment growth outpaced provider growth, as shown in Figure 7, above. The total number of providers grew by 2.41 percent between SFY2022 and SFY2023 and there was growing provider numbers in all the regions. The smaller regions by population also showed the percentage increases which is a good sign. The total units administered in each region increased between SFY2022 and SFY2023. This indicates

that a similar number of services are being provided by the providers who remain active in each region.





Figure 8. Total Providers by Region, SFY2019-SFY2023

Trends are somewhat different when examining the number of units administered by each provider in Figure 9, above. Generally, the number of providers grew faster than the number of units among the top services. However, given the increases in units in SFY2023 that are in line with historical growth rates, there does not appear to be a rate adequacy issue for HCBS providers.

# Analysis by Service Category

# **Residential Services**

The services that that comprise this service category include Group Home, Group Home Nursing Supported, Group Home Community Protection, and Developmental Home Child and Adult. In the exhibit below Guidehouse compared the CY2023 Benchmark Rates to the 1/1/2023 Adopted Rate to determine if the rates are adequate.

In reviewing the benchmark ratio, Group Home at 72 percent is significantly lower than the 85 percent of benchmark and should be looked at for future increases. Vendor Supported Development Home (Child) is also just below the 85 percent threshold at 83.60 percent. When reviewing this in conjunction with Figures 11 – 16 below there is not concern in total of Residential Services rate inadequacies as there is growth in all the metrics below. There is an increase in providers as well as paid per user and unit cost which indicates these service needs are being met.

The tables below breakout the paid amount, units, provider count, users, average paid per user, and average unit cost for each region by SFY.

## **In-Home Supports Services**

The services that that comprise this service category include Attendant Care, Habilitation (IDLA Hourly and Daily), Habilitation Support, Homemaker, Music Therapy, and Respite (Hourly and Daily). In the exhibit below Guidehouse compared the CY2023 Benchmark Rates to the 1/1/2023 Adopted Rate to determine if the rates are adequate.

In reviewing the benchmark ratio, Music Therapy at 80.14 percent and Homemaker at 82.81 percent is slightly lower than the 85 percent of benchmark and should be looked at for future increases. When reviewing this in conjunction with Figures 18 - 23 below there is not concern in total of rate inadequacies as there is significant growth in total paid, units, as well as providers to keep up with the increase in users. It wage does indicates these service needs are being met.

The tables below breakout the paid amount, units, provider count, users, average paid per user, and average unit cost for each region by SFY.

When reviewing this in conjunction with Figures 25 – 30 below there is significant growth in total paid, units, as well as providers to keep up with the increase in users. The one exception is Flagstaff where there were only fourteen providers in SFY2022 and that dropped to thirteen in SFY2023. After decreases in services during the pandemic, we are now seeing a shift back into the day treatment in SFY2022 and SFY2023.

When looking at the Professional Nursing Services benchmarks, the Continuous and Respite Services are all in the 84 percent range. Services with more skilled workers like Professional Nursing may require a longer timeframe to acquire more providers. The services that that comprise this service category include Respiratory Therapy, Occupational Therapy, Speech Therapy, and Physical Therapy. In the exhibit below Guidehouse compared the CY2023 Benchmark Rates to the 1/1/2023 Adopted Rate to determine if the rates are adequate.

In reviewing the benchmark ratio, all services with the exception of Respiratory Therapy are well below the 85 percent of benchmark at 79 percent. Like Professional Nursing Services, Professional Therapy Services with more skilled workers may require a longer timeframe to acquire more providers. The number of providers has remained relatively flat statewide and as a result the utilization and users have also remained relatively flat over the last two years indicating there may be a shortage in services available. Given all services are below the benchmark and utilization and providers have not grown, this is a service that should be examined closely in the rate rebase that is currently being completed.

The tables below breakout the paid amount, units, provider count, users, average paid per user, and average unit cost for each region by SFY.

# **Unassigned Authorizations and Qualified Vendor Analysis**

To better understand how and if user access to a provider may be impacting the delivery of certain services, we completed several analyses to determine whether there was capacity within the provider network to address unmet demands of the Users. There are several reasons providers may not be offering a certain service to Users; including insufficient rates, a lack of qualified staff to provide the service, or a business decision to not respond to a particular vendor call.

# **Unassigned Authorizations**




Figure 59. Unassigned Authorizations by Month and Service, March 2022 – February 2023

Unassigned Authorizations (UAs) are a process used by the Division to track outstanding requests for services. UAs track how many individuals are assessed for a service but are unable to receive these services due to difficulties finding a provider. For the first portion of the UAs analysis, Guidehouse examined the average number of daily UAs per month at a service category level in Figure 59 for the most recent 12 months available. This is calculated by taking the total number of UAs in a given month and dividing by the number of days in that month with at least one UA request.

Three services, Therapies, Respite, and Hourly Habilitation comprise the majority of UAs on a monthly basis, as shown in Figure 59. Respite UAs are somewhat less of a concern, as providers often put out requests for Respite services without having a direct need, in preparation for future demand. Even so, there were between 528 and 616 UAs for the Respite Services for each month between March 2022 and September 2022. There is a significant drop in October 2022 which appears to be an issue where the authorizations are made on year-long basis from October 1<sup>st</sup> - September 30<sup>th</sup> and there is a lag before they are re-entered in the system. The UAs rebound to slightly lower levels of Respite Services dropping from 567 in November to 442 by February 2023. UAs for Hourly Habilitation appear to slowly increase throughout the time period which could indicate that providers are not able to administer these services as quickly as they had been.

Similarly, Professional Therapies saw UAs consistently increase throughout the time period. It is important to note UAs from Professional Therapies began a rapid decrease in the spring of 2020 as COVID-19 was starting to ramp up. The drop in UAs during this time period may reflect the rapid adoption of Telehealth Services by therapy providers. UAs were in the range of 1250 in February 2020 and continued to decline into a range of three hundred in mid-2022. However, it may also be due to fewer members seeking therapy services, which previously required significant face to face contact with a provider in the home or at a clinic site. As more and more providers are shifting back to some in-person visits again and not just telehealth visits in 2023, that could explain the increase we are seeing in this 12-month time period. The other service groupings have relatively low UAs on a monthly basis and showed no significant patterns over the time period included in Guidehouse's analysis.

As a corollary to the previous chart, the Figure 60 below shows the average UAs per day for each service grouping. Note that several services, including Therapies, had a higher daily average than in SFY2022. The increase in UAs through the year before the COVID-19 emergency offset the drop in unassigned authorizations that began in March. Several services are excluded from this table, as they had less than 1 unassigned authorization per day, on average.

# **Qualified Vendor Analysis**

Guidehouse also examined Qualified Vendor data and compared the list of qualified vendors to vendors that submitted a claim during SFY2023. Overall, there were 711 qualified vendors, with 676 of the vendors submitted a claim in SFY2023. 95 percent of qualified vendors submitted a claim in SFY2023.

Figure 61 shows the data by service category by total paid, total paid by qualified vendors, the count of total qualified vendors, the count of qualified vendors with claims, percentage paid to qualified vendors, and the percentage of qualified vendors that submitted a claim. All service categories show more than 98 percent of paid claims are going to qualified vendors with the one exception being Transportation Services which were impacted during the pandemic and are slowly starting to recover. Although 95 percent of all qualified vendors are submitting claims in the program, Figure 61 shows that Transportation and Professional Therapy are the only service showing over 70 percent of qualified vendors with claims when reviewing the data by service category. The remaining service categories are in the range of 51 percent to 64 percent of qualified providers submitting claims. This indicates that although providers may be qualified to provider services in several different service groups, they may only be providing services in certain specific services.
