Barriers to quality of healthcare access on Tribal Nations




- Approximately 511,000 American Indian/Alaska Natives adults have at least one disability (U.S. Census, 2020)
- 2019, 5.9% of Al/AN child had an unknown or undetected disability (Young, 2021)

Barriers:

Lack of Tribal, State and Federal disability programs awareness	Lack of navigation of the educational system
Undetected medical/cognitive/developm ental disabilities	Rural access to medical care, providers and services




Arizona 22 Tribes

DDD Membership-Tribal and Non-Tribal






Health Plans in Arizona

- Tribal Health Plan has been a health plan for years for our DDD Tribal membership.
 - On April 1st, 2022, the Tribal Health Plan (THP) for DDD member was transitioned under AHCCCS DFSM. DDD still provides oversight.
- The focus of THP is to provide an extensive customer service driven health care services to ensure quality and equitable services are received and delivered in a timely and professional manner to our enrolled Developmental Disability Tribal membership.

DDD- Tribal Health Program



The DDD Tribal Health Program (THP): is a fee-for-service program that allows eligible members to receive services at any AHCCCS registered fee-for-service provider in Arizona that sees fee-for-service THP Members.

Tribal Health Coordinator

- Collaborate to increase health awareness and education of the DDD program
- Establish and maintaining cooperative relationship with IHS/638 clinics, Health Care facilities, Tribal Health Programs, TRBHA, Tribal Epidemiology Programs

Tribal RN Liaison

- Collaborates with departments within DDD and AHCCCS to increase supportive nursing service.
- Ensure transition of healthcare supportive services are carried from discharged planning to home environments

Utilization Manager

- Oversees the health plan components
- Aligned with AHCCCS DFSM
- CCM can assist with discharge planning
- Currently on call RN for the plan
