### **Division of Developmental Disabilities - DDD**


DDD provides supports and services to individuals diagnosed with developmental disabilities, such as

- Autism,
- Cerebral Palsy,
- Epilepsy,
- Cognitive/Intellectual Disability,
- Down Syndrome (added as a result of Legislation in 2022), or
- Children who are under the age of six and at risk of having a Developmental Disability.

DDD serves more than **48,000** Arizonans with developmental disabilities and their families each year.

## Federal COVID-19 Public Health Emergency

#### **COVID-19 Flexibilities Ending April 1, 2023**

- Virtual Person-Centered Service Plan Meetings
- Remote Learning Supports
- Assessing Risk for DDD Members Who Are At Higher Risk for Severe Illness From COVID-19 Guidance
- Requiring Qualified Vendors Providing Group Home or Developmental Home Services to Hold a Place for a Member Who Moves to Their Family Home Due to COVID Staffing Issues COVID Concerns

### **DDD Person-Centered Service Planning**

- AHCCCS is requiring DDD to return to the in-person model that DDD was using prior to COVID.
- This will be effective April 1st.
- Currently these are meetings every 90 days using the hybrid model

#### Parents As Providers for Their Minor Children

On January 30, 2023 the federal government announced their intent to end the COVID-19 public health emergency on May 11, 2023.

- Parents as Paid Providers for Their Minor Children is a flexibility approved at the beginning of the COVID-19 PHE.
- It continues to be a flexibility available to support members who need a direct support professional to deliver services.

#### Parents As Paid Providers cont.

When the federal PHE ends, this flexibility will still be available, but under the American Rescue Plan Act (ARPA) plan submitted by AHCCCS to CMS. It will be available under ARPA through September 30, 2024.

There are a few changes under the ARPA plan:

- Parents will not be allowed to provide more than 40 hours of total paid care per ALTCS member in any given week.
- The member may be assessed for more than 40 hours based on their needs.
- Each ALTCS member who is under the age of 18 can receive paid care from a parent for up to 40 hours a week.
- AHCCCS has updated its <u>FAQ</u> related to the parents as paid caregivers for their minor children flexibility.
