
COVID-19

DDD's top priority is the health and safety of our members, their families, and the professionals in our program that support them


The Division of Developmental Disabilities (DDD) is:




Physical Therapy Telehealth




Speech Language Pathology Telehealth




Day Programs Telehealth




COVID-19 Member Positive Tests



As of November 3, 2020

- 930 total members have tested positive for COVID-19 since March; DDD started publishing the data in June
- 491 members living in their own or family home had tested positive for COVID-19
- 439 members living in a licensed residential facility had tested positive for COVID-19


COVID-19 Member Mortality




As of November 3, 2020

- 44 total members have passed away as a result of COVID-19
- 11 members lived in their own or family home (note: there was one new death in the last week for a member living in their own home or family home)
- 33 members lived in a licensed residential facility (note: there have been no new deaths since September 15 in licensed facilities)

WHAT DOES THE ADDPC DO?

Vision: One community working together to achieve full inclusion and participation of people with developmental disabilities.





ADDPC Goals (2017-2021)

GOAL 1 – SELF-ADVOCACY/SELF-DETERMINATION

We aim to establish, strengthen, and expand self-advocacy activities among people with developmental disabilities so they will become empowered to be self-determined


GOAL 2 – EMPLOYMENT

We will increase awareness of employment potential of people who have developmental disabilities, link them to resources needed to achieve their employment potential, and foster job creation, hiring, retention, promotion, and self-employment.

GOAL 3 – INCLUSION

We want to motivate communities to include people of all ages who have developmental disabilities in every aspect of community life by supporting programs, changing policies/procedures, and removing systemic barriers to maximize self-determination and diminish discrimination, neglect, abuse and exploitation.

ADDPC Required Activities

Governor-appointed 23-member Council with 6 staff. The Council <u>SHALL</u>:

- Serve as a forum through which issues regarding people with DD may be discussed Ex: AZ DD Network Town Halls
- Review and make recommendations on services and programs for people with DD and make those recommendations available to the Governor, Legislature and government agencies as requested
- Monitor programs and services to encourage efficient and coordinated use of resources
- ✓ Advise the public and private sector on programs, policies, and concerns pertaining to services for persons with DD and their families



What are Councils on Developmental Disabilities (DD)?

- Authorized through federal DD Assistance and Bill of Rights Act of 2000
- Federally funded, self-governing organizations in every state and territory
- Engage in "advocacy, <u>system change</u>, and capacity-building" addressing most pressing needs of people with DD in each region
- Advance public policy that help individuals gain more control over their lives

"Provide information to policymakers by supporting and conducting studies and analyses, gathering information, and developing and disseminating model policies and procedures, information, approaches, strategies, findings, conclusions, and recommendations directly to Federal, State, and local policymakers,... and State agencies." *(Public Law 106-402)*



What is system change?

Systems change is about addressing the root causes of social problems. It aims to bring about lasting change by altering underlying structures and supporting mechanisms which make the system operate in a particular way. These can include policies, routines, relationships, resources, power structures and values.

SYSTEM CHANGE

- Advocacy
- Collaboration with state agencies and organizations around systems change
- Training
- Research
- Information dissemination & story-telling
- Project funding



Council Goal Revised to Include:

"...diminish discrimination, neglect, abuse and exploitation"



<u>Respite</u>: the care of a loved one by another person to give the caregiver a break. It can be provided by a friend, neighbor, day center, or home care agency

- Adult Day Health Center Respite Scholarship Program
 - Up to 96 hours of respite at no cost to those caregivers who have never received aid from any federal program
 - Caregiver must live full-time with the care recipient and not work outside the home
- Respite Vouchers for In-Home Respite
 - \$300 can be renewed for another \$299 afterwards
 - Caregiver must be primary and not receiving respite from any other public program





Family Caregiver Reimbursemen t Program (FCRP)

Goal	Enable caregivers to provide their qualified family members mobility, safety, and independence in the effort of avoiding institutional care
How it works	Caregivers can be reimbursed for 50% or up to \$1,000 for home modifications and assistive care technology
Requirement	Care receiver must be 18 years or older and require help with one or more activities of daily living

Arizona Family Caregiver Reimbursement Program

- The Arizona Family Caregiver Reimbursement Program (FCRP) assists family caregivers with a partial reimbursement for home modifications and assistive care technology.
- The FCRP assists family caregivers to enable their qualified family member to be mobile, safe, and independent to avoid institutional care.
- The FCRP is open to residents of Arizona that meet the eligibility requirements.
- This program is first come, first serve.

Arizona Family Caregiver Reimbursement Program

- Family Caregivers can be reimbursed 50% for home modifications and assistive care technology up to \$1,000 for one (1) or more care recipients.
- Home modifications must be completed in the calendar year
 - Installation charges by family members are allowable
- Assistive care technologies:
 - Receipts must be within the calendar year
 - Cumulative receipts are allowable for items that are paid for on a monthly basis i.e., Personal Emergency Response Systems, Medication Management Systems, or computer applications that are paid for monthly.

Family Caregivers

- The family caregiver must be the qualified family members'
 - Spouse
 - Child
 - Grandchild
 - Stepchild
 - Parent or Stepparent
 - Grandparent
 - Sibling
 - In-law
 - Uncle or Aunt
 - including half blood or by adoption.
- Family Caregiver may apply up for (1) or more care recipients.

Qualifying Family Member

The qualifying family member:

- Must be 18 years or older
- Must be an Arizona resident
- Requires help with one (1) or more activities of daily living (ADLs)
- Must have a Medical Need Verification Form signed by a
 - Primary Care Provider (PCP)
 - Nurse Practitioner (NP)
 - Physician's Assistant (PA)
- Must meet income eligibility

Arizona Family Caregiver Reimbursement Program

Starting January 1, 2020, family caregivers can receive a 50% reimbursement up to \$1.000 for home modifications and assistive care technology. The family member must be 18 years or older, and requires help with one (1) or more daily tasks.





Important: 巜

- Home modifications and assistive care technology purchases must occur on or after January 1, 2020.
- Applications are reviewed on a first-come, first serve basis due to limited funding.
- Family caregivers who receive reimbursement are not eligible to apply again for three (3) consecutive calendar years.
- For reimbursement over \$600 a 1099 tax form will be provided.

Programa de reembolso para cuidadores familiares de Arizona

A partir del 1 de enero de 2020, los cuidadores familiares pueden recibir un reembolso del 50% hasta \$1,000 por adaptaciones en el hogar y tecnología de asistencia. El miembro de la familia debe tener 18 o más años y requiere la ayuda con una (1) o más tareas diarias.



Importante: 巜

- Las adaptaciones en el hogar y las compras de tecnología de asistencia deben ocurrir a partir o después del 1 de enero de 2020.
- Las solicitudes se revisan por orden de llegada debido a la escasez de fondos.
- Los cuidadores familiares que reciben reembolso no podrán solicitar de nuevo por tres (3) años calendario consecutivos.
- Se proporcionará un formulario fiscal 1099 para reembolsos de más de \$600.

Home Modification

Improving or altering the family caregivers' residence whether it be owned or rented.

Home Modification (not an inclusive list):

- Widening of doorways
- Ramps/low inclined walkways
- Adaptive switches
- One-bathroom environment
- (Roll-in/curb-less) accessible shower
- Roll-under sink
- High rise toilet with handrails
- Handrails and grab bars in accessible shower

Assistive Care Technologies

Purchasing/leasing equipment or assistive care technology for the family member to enable/assist and/or carry out one or more activities of daily living such as toileting, bathing, dressing, grooming, eating, mobility, or transferring.

Assistive Care Technology

- Hearing aids
- Eating: adaptive utensils, dentures
- Transferring: Hoyer lift, gait belt, stairlift chair
- Toileting; bedside commode
- Bathing: shower chair/bench, handheld shower head
- Vehicle wheelchair lift
- Dressing assistance; buttoning aid hook, long reach comfort wipe
- Medical alert devices
- *Many more!* Call the Caregiver Resource Line to discuss your needs.

- Regular food, clothing, transportation expenses or gifts provided to family member.
- Ordinary household maintenance or repair that is not directly related to and necessary for the care of the family member.
- Any amount that is paid for or reimbursed by the federal government or State of Arizona.
- Reimbursement does not include covered expenses from the family member's insurance policy.

Is this Reimbursement Program taxable?

- For reimbursement over \$600, a 1099 tax form will be issued by the Arizona Department of Economic Security (DES) to the family caregiver.
- Reimbursements over \$600 is considered taxable income.

IMPORTANT NOTE:

• Family caregivers who receive reimbursement are <u>not</u> eligible to apply again for three (3) consecutive calendar years.
