INTERGOVERNMENTAL AGREEMENT DI16-002166 - AMENDMENT THREE (3)

Intergovernmental Agreement DI16-002166 between the Arizona Department of Economic Security (ADES) and the Arizona Department of Education (ADE), the Arizona Department of Health Services (ADHS), the Arizona Health Care Cost Containment System (AHCCCS), and the Arizona State Schools for the Deaf and the Blind (ASDB), all state agencies of the State of Arizona, is hereby amended.

THE PARTIES AGREE TO THE FOLLOWING AMENDMENT:

In accordance with the terms and conditions, Section 3.2., Extension, the contract is extended for the period from December 31, 2021 to June 30, 2022.
