

Navigating Medicare



What is SHIP?

The State Health Insurance Assistance Program (SHIP) is a free health benefits counseling service for Medicare beneficiaries.

Our mission is to empower, educate, and assist Medicare-eligible individuals, their families, and caregivers through objective outreach, counseling and training, to help individuals make informed health insurance decisions that optimize access to care and benefits.

SHIP is an independent program federally funded by the Administration for Community Living and is not affiliated with the insurance industry.



SHIPs Provide Local Medicare Help



Certified Medicare counselors provide:

- In-depth individualized counseling
- Educational presentations about Medicare

- Aging and Disability Resource Centers

You can count on SHIP to help with:

- understanding and comparing coverage and costs for Original Medicare, parts A,B,C and D so informed choices can be made
- paying for Medicare and prescriptions
- troubleshooting billing issues
- submitting appeals on billing errors
- making decisions during Open Enrollment
 - October 15 December 7 each year
- navigating through Special Enrollment Periods
- referrals to other helpful resources

What About MIPPA?

The Medicare Improvement for Patients and Providers Act (MIPPA) program helps Medicare beneficiaries with limited income and assets learn about programs that may save them money on their Medicare costs. MIPPA supports targeted outreach and education to eligible Medicare beneficiaries, especially those who are:

- Low-income with limited resources
- Residents of rural areas
- Members of American Indian, Alaskan
 Native, and Native Hawaiian communities
- People with disabilities under age 65
- Speakers of English as a secondary language

How does MIPPA Help?

MIPPA educates Medicare beneficiaries about existing programs that can help save money on their health care costs. These programs include:

- Medicare Part D Low-Income Subsidy (LIS)/Extra Help: Administered by the Social Security Administration, this program helps to lower Medicare Part D costs – including out-of-pocket costs for premiums, deductibles, and prescription drugs – for beneficiaries who meet certain income and resource eligibility requirements.
- Medicare Savings Programs (MSPs): Administered by state Medicaid agencies, MSPs can help pay some Medicare costs for health care, including Medicare Part B premiums, for eligible beneficiaries. These programs have four levels of benefits, each with its own eligibility requirements: Qualified Medicare Beneficiary (QMB), Specified Low-Income Medicare Beneficiary (SLMB), Qualifying Individual (QI), and Qualified Disabled Working Individual (QDWI).
- Medicare Preventive Services: MIPPA grantees also educate the community about Medicare Preventive Services, which cover many preventive health services such as the "Welcome to Medicare" preventive visit, yearly "Wellness" visits, vaccinations like the flu and COVID-19, screenings for cancer and heart disease, and more. These services are available to all Medicare beneficiaries, regardless of their income and assets.
