1. Data may be duplicative of PUA and regular UI claims as individuals PUA eligible may be financed by regular UI trust fund, the PUA portal going live.  
 2. This benefit paid amount is inclusive of state and federally financed programs. Regular UI is financed by the UI trust fund, whereas FPUC and EB are 100% federally financed.  
 3. Continued claims represent weekly filings and are not unique individuals (Individuals are counted for each week claimed).  
 4. Due to retroactive eligibility, benefits paid may be for more than one week.  
 5. It is possible that some claimants were eligible for PUA, after exhausting their UI benefits and before PEUC became available through the CARES Act.  
 6. Year-to-date comparison of weekly averages.  
 7. Prior to the deployment of the PUA portal, the Department determined 165,444 individuals eligible for the PUA program based on the information provided in their initial Unemployment Insurance claim. The portal began accepting initial claims on 5/17/2020 and weekly certifications on 5/17/2020.  
 8. Unduplicated count of UI claimants is inclusive of data since the beginning of the pandemic, while unduplicated count of PUA claimants paid is inclusive of data from program inception to date.  
 9. Numbers are based on current system figures. Data is subject to change as final numbers are provided to Department of Labor.  
 10. Significant declines in initial and continued PUA claims are largely attributable to a change DES initiated within the PUA portal to deter fraudulent activity.  
 11. Total includes all benefits disbursed since March 7th including PUA, UI, FPUC, LWAP, EB, PEUC, and STC.  
 12. Call center average calls handled includes calls to DES and Valor call centers.
