- Employment Service (ES) offices where MSFWs account for 10% or more of annual participants in employment services, or
- ES offices that the administrator of the Office of Workforce Investment under Department of Labor (DOL) determines must be included due to special circumstances, such as an estimated large number of MSFWs in the service area
